AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

This Amendment to the Declaration of Covenants, Conditions and Restrictions ("Declaration") that established a planned residential community known as Scandia Village Condominiums is executed on the date set forth below by the Scandia Village Condominium Owners Association ("Association") having received the necessary approvals of the unit owners.

RECITALS

- A. Certain real property in Utah County, Utah, known as Scandia Village Condominiums was subjected to certain covenants, conditions, and restrictions pursuant to a Declaration recorded November 6, 1992, as Entry No. 60681:1992, records of Utah County, Utah;
- B. This amendment shall be binding against the property described in EXHIBIT A and the Declaration and any annexation or supplement thereto;
- C. This amendment is intended to clarify maintenance and insurance obligations between the Association and to change the way reserve funds are spent;
- D. Pursuant to Article XII, Section 12.03 of the Declaration Owners representing more than two-thirds (2/3) of the undivided ownership interests in and to the Common Areas have approved the amendments to the Declaration;
- E. Pursuant to Article I, Section 1.10 of the Bylaws Owners representing more than fifty-one percent (51%) of the undivided ownership interests in and to the Common Areas have approved the amendments to the Bylaws.

NOW, THEREFORE, the Association, by and through its Management Committee, hereby amends the Declaration as follows:

Article VII, Section 7.03 of the Declaration shall be amended to include the following language:

The Association shall also maintain the pipes inside the walls, floors, or ceilings of the buildings.

Article VII, Section 7.06A of the Declaration shall be added and shall read as follows:

7.06A Payment of Monies from the Reserve Accounts. Any check drawn on the reserve account or withdrawals from the reserve account shall require at least two (2) signatures from members of the Management Committee.

Article I, Section 1.14 of the Bylaws shall be amended to add the following language:

The Association shall also maintain the pipes inside the walls, floors, or ceilings of the buildings.

Article I, Section 1.17A of the Bylaws shall be added and shall read as follows:

1.17A <u>Payment of Monies from the Reserve Accounts</u>. Any check drawn on the reserve account or withdrawals from the reserve account shall require at least two (2) signatures from the members of the Management Committee.

IN WITNESS WHEREOF, SCANDIA VILLAGE CONDOMINIUM OWNERS ASSOCIATION, by and through its Management Committee, has executed this Amendment to the Declaration as of the 23 day of March, 2009, in accordance with the Declaration.
