DECLARATION OF COVENANTS CONDITIONS AND RESTRICTIONS OF MILLCREEK COTTAGES

THIS DECLARATION of Covenants, Conditions and Restrictions is made on the date hereinafter set fortit to establish a planned unit development known as Millcreek Cottages - Phase One.

RECITALS

WHEREAS, Declarant is the owner of certain real property in the City of St. George, County of Washington, State of Utah, which is more particularly described below, and

WHEREAS, Declarational convey the properties subject to certain protective covenants. conditions, restrictions, reservations, assessments, charges and liens as hereinafter set forth and

WHEREAS this the desire and intention of Declarant to construct detached single family dwellings on the properties and sell and convey the same to various purchasers.

DECLARATION

NOW, THEREFORE, Declarant hereby declares that all of the properties described below shall be held, sold and conveyed and occupied subject to the following covenants, conditions. restrictions, easements, assessments, charges and liens, and the man recorded herewith entitled Millcreek Cottages-Phase One consisting of one sheet, prepared and certified by Boyd R. Uries a Utah Registered Land Surveyor, which are all for the purpose of protecting the value and desirability of, and which shall be construed as covenants of equitable servitude and shall run with the properties and be kinding on all parties having any light, title or interest in the properties or any part thereof, their heirs, successors and assigns, and shall inure to the benefit of each owner thereof:

SEC. 14, T42S, R16W, SDB&M, AND RUNNING THENCE NORTH 397.64 FT., THENCE N 89'31'58" E 292 (1) FT., THENCE SOUTH 327.18 FD., THENCE S 89'32'40" W 17.01 FT., THENCE SOUTH 70 23 FT., THENCE S 89:29:96" W 275.00 FT. TO THE POINT OF BEGINNING CONTAINING 2 647 ACRES.

ARTICLE I - DEFINITIONS

- Section 1. Declaration shall mean and refer to this instrument, and any amendments.
- Section 2. Plat or Map shall mean and refer to the subdivision plat recorded herewith/captioned "Millcreek Cottages-Rhase One," or any replacements thereof, or additions thereto)
- Properties shall mean and refer to that certain real property hereinbefore Section 3. described, and such additions thereto as may hereafter be subjected to this Declaration.
- Common Area shall mean and relegate that portion of property owned by Section 4. the Association and slown on the plat as dedicated to the common use and enjoyment in owners.
- Section 5. Limited Common Area shall mean and refer to that portion of property owned by the Association and shown on the plat as dedicated to the exclusive use and enjoyment of the owner of the lot to which such limited common area is adjacent and/or appurenant, subject to rights of the Association, as herein set forth.

- Section 6. Lot small mean and refer to any separately numbered and individually described plot of land shown on the plat, designated for private ownership, and shall exclude the common and limited common areas.
- Section 7x Townhome shall mean and refer to a single family dwelling with or without walls or roofs in common with other single family dwelling lots, and shall include fee title to the real property lying directly beneath said single family dwelling.
- Owner shall mean and refer to the entity, person of group of persons Section 8. owning fee simple title to any lot which is within the properties. Regardless of the number of parties participating in ownership of each lot, those parties shall be treated, as a group, as one owner."
- Association shall mean and refer to Millcreek Cottages Association its Section 9. successors and assigns.
- Section 10. Member shall mean and teller to every person or entity who holds membership in the Association.
 - Section 11. <u>Trustees</u> shall mean and refer to the governing body of the Association.
- Section 12. Declarant shall mean and refer to Jay Ence and his heirs, successors and

ARTICLE II -- PROPERTY RIGHTS

- Section 1. Title to the Common Area The Declarant, its successors and assigns, will convey the simple title to the common area and limited common area to the Association, free and clear of all encumbrances and kens, properto the conveyance of the first to subject to covenants, restrictions, easements, encumbrances and liens created by or pursuant to this Declaration, easements and rights-of-way of record, and a covenant by the Association to maintain the common area in good repair and condition at all times and to operate the same at its own expense in accordance with high standards, which covenants shall be deemed to run with the land and shall be binding upon the Association, its successors and assigns
- Section 2. Owners' Easements of Enjoyment Every owner shall have a night and easement of use and enjoyment in and to the common area which easement shall be appurtenant to and shall pass with the title to every lot, subject to the following provisions:
- The right of the Association to charge reasonable admission and other fees for the use of any recreational facility situated upon the common area.
- Xb) The right of the Association to limit the number of guests of members using the common area.
- The right of the Association to suspend the voting rights of a member for any (C) period during which any assessment against his lot remains ungain; and for a period of not to exceed sixty (60) days for any infraction of its published rules and regulations.
- With the approval of all first mortgagees on total and sixty-seven percent (67%) of the owners, the right of the Association to sell, exchange, hypothecate, alienate, mortgage, encumber, dedicate, release or transfer all or part of the common area to any private individual. corporate entity, public agency, authority, or utility. The granting of easements for public utilities or other public purposes consistent with the intended use of such common area by the Mothicial Color Association shall not be deemed a transfer within the meaning of the next preceding clause, and such grants may be made by the Association.

(e) The right of the Association to take such steps as are reasonably necessary or desirable to protect the common area against foreclosure.

(f) The right of each individual lot owner to the exclusive use of the limited common area adjacent and appurenant to his respective lot, and the right of each owner to exclusive use of the parking area many, designated with his lot number on the plat.

(g) The terms and conditions of this Declaration.

Section 3. <u>Limited Common Area</u> Ownership of each lot shall entitle the owner thereot to the exclusive use of the immed common area adjacent and appurtenant thereto

Delegation of Use Any owner shall be deemed to delegate his right of enjoyment to the common area and facilities to the members of his tarrily, his tenants, or contract purchasers who reside on the property. No one who is non-resident shall have any such right of enjoyment.

Section 5. <u>Driveways</u> The driveway appurturant to each townhome shall be subject to the exclusive use of the owner, notwithstanding it may be platted as common area. It shall, however, in all other respects, be treated as common area.

Section 6. Lot Area outside Townhome Boundaries. In the event any townhome does not occupy the entire area of the lot on which it is placed, the lot area outside the townhome extends walls shall be treated as limited common area for the exclusive use and enjoyment of the lot, subject to the rights of the Association in such limited common area as herein set both.

ARTICLE III -- MEMBERSHIP AND VOTING RIGHTS

Section Membership Every person of entry who is owner of any lot shall be a member of the Association. The term "owner" shall include contract purchasers but shall not include persons or entities who hold an interest merely as security for the performance of an obligation unless and unbl said holder has acquired title pursuant to foreclosure or proceedings in lieu of breclosure. Membership shall be appurtenant to and may not be separated from ownership of any lot. Membership in the Association shall automatically transfer upon transfer of title by the record owner to another person or entity.

Section 2. <u>Voting Plights</u> The Association shall have two classes of voting membership:

CLASS A. Class A members shall be all members with the exception of the Declarant and shall be entitled to one vote for each lot owned. When more than one person holds an interest in any lot, the group of such persons shall be a member. The vote for such lot shall be exercised as they among themselves determine, but in no event shall more than one vote be cast with respect to any lot. A vote cast at any association meeting by any of such co-owners, whether in person or by proxy, shall be conclusively presumed to be the vote attributable to the lot concerned unless written objection is made prior to said meeting, or verbal objection at said meeting, by another co-owner of the same lot. In the event objection is made, the vote involved shall not be counted for any purpose except to determine whether a querim exists.

CLASS B. The Class B member shall be the Declarant (as defined in the Declaration,) and shall be entitled to three (3) votes for each lot whed The Class B membership shall cease and be converted to Class A membership on the happening of either of the following.

ARTICLE IV - FINANCES AND OPERATIONS

Creation of the Lien and Personal Obligation (s) Assessments The Declarant for each lot owned by him within the properties hereby covenants and each owner of any lot by acceptance of a deed therefor, whether or not it shall be so expressed in any such deed or other conveyance, is deemed to covenant and agree to pay to the Association (1) annual : assessments or charges and, (2) special assessments to capital improvements, such assessments to be fixed established, and collected from the to time as hereinafter provided The annual and special assessments, together with interest, costs of collection and a reasonable attorney's tee, as hereinafter provided, shall be a charge on the land and shall be a continuing lien upon the property against which each such assessment is made. Each such assessment, together with interest, costs of collection and a reasonable attorney's fee, as hereinafter provided, shall also be the personal obligation of the person who was the owner of such property at the time when the assessment tell due. The personal obligation for defination assessments shall not pass to his successors-in-title unless expressly assumed by them.

Purpose of Assessments The assessments levied by the Association shall be used exclusively for the purpose of promoting the recreation, health, safety, and wellare ... of the residents of the pagagities and in particular for the improvement and maintenance of properties, services, and aclities devoted to this purpose and related to the use and enjoyment of the common areas and of the townhomes situated upon the properties. The assessments must provide for but are not limited to, the payment of taxes and insurance, the payment of the cost of repairing, replacing, maintaining and constructing or acquiring additions to the common and limited common areas, the payment of the cost of repairing, replacing, and maintaining the exteriors of each lot, the payment of administrative expenses of the Association, Insurance deductible amounts, and the establishment of a reserve account for repail maintenance and replacement of those common and limited common areas which must be oplaced on a periodic basis, and the assessments may provide, at the discretion of the Trustees, for the payment of other charges, including, without limitation, trash collection, sewer and water costs required by this Declaration or that the Trustees shall determine to be necessary to meet the primary purposes of the Association.

Basis and Maximum Annual Assessments Until January 1 (ellowing recording of this Declaration, the maximum annual assessment shall be Five Hundred Pollars (\$500.00) per lot. This amount shall be the basis of calculation for future maximum annual assessments.

From and after the date referred to above the maximum annual assessment may be increased once a year by the Trustees without a lote of the members by an amount equivalent to the decrease in the real value of the amount stated above, as determined by reference to the change in U.S. City Average Consumer Price Index for all Urban Consumers published by the U.S. Department of Labor, Bureau of Labor Statistics, as it changed from one year prior to the date referred to above, to the date of fixing the maximum assessment by the Trustees

From and after the above-referenced date the maximum annual assessment may be increased above the Annual Cost of Living percentage increase by a vote of sixty, seven percent (67%) of each class of members voting, in person or by proxy. at a meeting duly called for this purpose

The maximum annual assessment shall be increased automatically. Moltiple of A without vote, by an amount equal to actual increases in the amounts payable for taxes, Declaration of Covenants, Conditions and Restrictions of Milkreek Cottages Townhomes

- The Trustees may, after consideration of current and future needs of the land an amount not to exceed the maximum. (d) Association, fix the annual assessment at an amount not to exceed the maximum.
- Special Assessments for Capital Improvements In addition to the applical Section 4. assessments authorized by Section 3 hereof, the Association may levy in any assessment year a special assessment, applicable to that year only, for the purpose of delraying, in whole or in part, the cost of any construction or reconstruction, repair or replacement of common or limited common area structures, fixtures and personal property related thereto, provided that any such assessment shall have the assent of sixty seven percent (67%) of the votes of all of the members authorized to vote, in person or by proxital a meeting duly called for this suppose.
 - Change in Basis and Maximum of Annual Assessments The Association may change the basis and maximum of the assessments fixed by Section 3 hereof prospectively. for any annual period provides that any such change shall have the assent of sixty-seven percent (67%) of the votes of each class of members, voting in person or by proxy, at a meeting duty called for this purpose.
 - Additional Assessments In addition to the annual assessments and special assessments for capital improvements authorized herein, the Association shall levy such assessments as may be necessary from time to time for the purpose of repairing and restoring the damage or disruption resulting to streets or other common or limited common areas from the activities of the City of St. George in maintaining, repairing or replacing white lines and facilities thereon, it being acknowledged that the ownership of utility lines, underground or otherwise is in the City up to and including the meters for individual units, and that they are installed and shall be maintained to City specifications
 - Section 7. Notice and Quorum for Any Action Authorized Under Sections 3. 4 and 5 Written notice of any meeting of members called for the purpose of taking any action authorized under Sections 3, 4 or 5 shall be sent to all members at least thirty (30) days in advance of said meeting. At the first meeting called, the presence at the meeting of members, or of proxies, entitled to cast sixty percent (60%) of all the votes of each class of membership shall constitute a quorum. If the required quorum is not forthcoming at such a meeting, another meeting may be called subject to the notice requirement set forth, and the required quorum at any such subsequent meeting shall be one tall of the required quorum at the preceding meeting, provided that no such subsequent meeting shall be held more than sixty (60) days following the preceding meeting.
 - Section 8. Uniform Rate of Assessment: Periodic Assessment Both annual and special assessments must be fixed at a uniform rate for all lots. This method of determining the assessments, dues, and charges may not be changed without the prior written approval of sixtyseven percent (67%) of first mortgagess.

Both annual and special assessments may be collected on a monthly, quarterly or semiannual basis.

Section 9. Date of Commencement of Annual Assessments: Dutles of Trustees: Due Dates: Adjustment of Assessments in Certain Cases. The annual assessment provided for merein shall commence to accrue on the date fixed by the Trustees of the Association to be the date of commencement.

The first annual assessments shall be adjusted according to the number of months remaining in the calendar year and may commence immediately upon determination by the Trustees At least thing (30) days prior to the commencement of each new assessment period, the Trustees shall send or cause to be sent a written notice of the annual assessment to each owner subject therato. Receipt of notice shall not be a pre-requisite to validity of the assessment.

The due dates shall be established by the Trustees, upon which dates the assessments for any year shall become due and payable; provided, that the Trustees may provide for the payment of annual and special assessments in equal installments throughout the assessment Marking Cold year. The due date of any special assessments authorized herein shall be fixed by the Trustees. subject to the same notice and payment requirements pertaining to annual assessments.

The Trustees shall prepare a roster of the properties and the assessments applicable thereto at the same time that it shall fix the amount of the annual assessment, which roster shall be kept by the Treasurer of the Association, who shall record payments of assessments and shall allow inspection of the roster by any member at reasonable times.

The Association shall, upon demand, and for a reasonable charge, furnish a certainate signed by an officer of the Association setting forth whether the assessment on a specified lot has been paid. Such certificates, when properly issued, shall be conclusive evidence of the payment of any assessment or fractional part thereof which is therein shown to have been paid.

A first mortgagee who has made a written request including the mortgagee's name and address, and the lot number of the unit it has the mortgage on is entitled to a written certificate from the Association advising of any deliault in the performance by an ewner of any obligation due under the Declaration which is not build within sixty (60) days.

Section 10. Effect of Non-Payment of Assessment Remedies of the Association Any assessment or installment thereof not paid within thirty (39) days after the due date thereof shall be delinquent and shall bear interest from the due date at the rate of eighteen percent (18%) per annum (or such different rate as the Trustees shall determine appropriate) until paid.

The Association may bring an action at law against the owner personally obligated to pay any such delinquent assessment without waiving the lien of assessment, or may foreclose the lien against the property in accordance with the laws of the State of Utah applicable to the exercise of powers of sale in deeds of trust or to the foreclosure of mortgages, or in any other manner permitted by law, or may restrict, limit, or otally terminate any or all services performed by the Association in behalf of the delinquent member, and there shall be added to the amount of such delinquent assessment the costs and expenses of said action, sale or foreclosure, and a reasonable attorney's fee, together with an account for the reasonable rental for the lot from time to time of commencement of the foreclosure and the Association shall be entitled to the appointment of a receiver to collect the rental without regard to the value of the other security.

A power of sale is hereby conferred upon the Association which it may exercise and under which the lot of an owner may be sold in the manner provided by Utah law pertaining to deeds of trust as it said Association were beneficiary under a deed of trust. The Association may designate any person or entity qualified by law to serve as Trustee for purposes of power of sale foreclosure.

No owner may waive or otherwise escape liability for the assessments provided for herein by nonesse of the common area or by abandonment of his lot.

- Section 11. Subordination of the Lien to Mortgages. The tien of the assessments provided for herein shall be subordinate to the lien of any first mortgage if the mortgage was recorded prior to the date the assessment became due. Sale or transfer of any lot shall not affect the assessment lien. However, the sale or transfer of any or purcuant to foreclosure of a first mortgage or any proceeding in lieu thereof, shall extinguish the lien of such assessment as to payments which became due prior to such sale or transfer. No such sale or transfer shall relieve such lot or owner from the lien thereof.
- Section 12 <u>Exempt Properties</u> The following property subject to this declaration shall be exempted from the assessment, charge and lien created herein:
 - (a) Any properties dedicated and accepted by the local public authority and devoted to public use.
 - (b) All common and limited common area;

However, no land or improvement devoted to dwelling use shall be exempt from said assessment, charge and lien.

Section 13. <u>Insurance</u> The Trustees of the Association, or their duly authorized agents, shall obtain and continue in effect:

(a) Property damage insurance, in one of the following alternate forms:

Molflicial Colf. a policy of property insurance equal to full replacement cost (exclusive of land, foundation, excavation and other like items) of the common area, limited common area, and improvements thereon.

The Association shall also require each owner to obtain a similar policy of insurance covering full replacement value (exclusive of land, tomoration, excavation and other like items) of his lot and improvements thereon with an endorsement listing the Association, "for the use and benefit of the lot owners" as an additional named insured with a provision that the policy may not be cancelled upon less than thirty days written notice to the Association; or

In the alternative to the obtaining of insurance specified previously in subparagraph (i) the Association may obtain a "master" or "blanket" policy of insurance equal to full replacement cost (exclusive of land, foundation, excavation and other like items) of the lots, common areas, limited common areas, and improvements thereon, with an endorsement listing the Association, for the use and benefit of the lot owners" as an additional named insured with a provision that the policy may not be cancelled upon less than thirty days written notice to the Association.

Un official Color Insurance procured under this subparagraph (a) shall (1) include an agreed amount endorsement or its equivalent, if available, or an inflation guard endorsement, (2) include construction code endorsement, providing that coverage shall be extended to the cost of construction, if any, required by reason of code provisions requiring changes to undamaged portions of partially demotished premises be made in accordance with current building codes and (3) afford protection against at least loss or damage by the and other hazards covered by the standard extended coverage endorsement, and by debris removal, cost of demolition, vandalism, malicious mischlet, windstorm, and water damage and such other risks as are customanly covered in similar projects. The maximum deductible shall be \$10,000.00 or 1% of the colory amount whichever is lesser. except in case of coverage related to individual units in which case the deductible shall be the \$1,000 00 or 1% of the policy amount, whichever is lessen

a comprehensive policy of public liability insurance covering all of the (b)\(a comprehensive policy of public flability Insurance covering all of the common and limited common property for at least \$1,000,000.00 per occurrence for personal and legal liability that results from employment contracts to which the Association is a party. Such liability insurance policy shall contain a "severability of interest" clause or endorsement which shall preclude the insurer from denying the claim of an owner because of degligent acts of the

Association or other owners.

fidelity coverage against_dishonest acts of the part of managers, Trustees, officers, employees, volunteers management agents or others responsible for handling funds held and collected for the benefit of the owners or members. Said fidelity insurance shall (1) name the Association as obligee or beneficiary, and (2) be written in an amount not less than the sum of (i) three months operating expenses and (ii) the madmum reserves of the Association which may be on deposit at any time, and (3) contain walvers of any defense based on the exclusion of persons who serve without compensation from any definition of "employees"

Insurance Policy Provisions Any insurance obtained by the Association Section 14. shall provide that:

Section 15. Insurance Related Provisions Premiums for insurance obtained by the Trustees pursuant to these sections shall be a common expense of the Association and shall be collectable from members of the Association as part of the annual assessments.

Each owner shall insure his own personal property and may insure his real property for his øwn Denefit.

Notwithstanding any other provisions herein, the Association shall continuously maintain in effect such casualty, flood and liability insurance and a fidelity bond meeting the insurance and fidelity bond requirement for blanned unit development projects. fidelity bond requirement for planned unit development projects established by Federal National Mortgage Association and Government National Mortgage Association, so long as either is a mortgages or owner of a bot within the project, except to the extent such coverage is not available or has been waived in writing by Federal National Mongage Association or Government National Mortgage Association

A first mortgagee who has made written request including the mortgagee's name and address, and the lot number of the unit it has the mortgage on shall be entitled to receive written notice of lapse, cancellation or material modification of any insurance policy or fidelity bond maintained by the Association.

Section 16. Damage or Destruction In the event of damage or destruction by fire or other casualty to any portion of the development covered by insurance written in the name of the Association, the Trustees are empowered to and shall represent the members in any proceedings, negotiations settlements or agreements the Association being appointed attorney-in-fact of each where for this purpose. The Association shall, with concurrence of the mortgagees, if any upon receipt of the insurance proceeds, contract to rebuild, restare or repair such damaged or destroyed portions of the development to its former condition. Unless at least sixty-seven percent (67%) of the owners and sixty-seven percent (67%) of first mortgagees have given their prior written approval the Association shall not be entitled to use insurance proceeds for other than the repair, replacement or reconstruction of the damaged or destroyed property.

In the event the insurance proceeds are insufficient to pay all the costs of repairing. restoring or rebuilding the Trustees shall be empowered to levy a special assessment against all owners of damaged townhomes or owners with damaged adjacent common area in such proportion as the Trustees deem equitable to make up any deficiency for repair of townhomes or limited common area, and the Trustees shall further be empowered to levy a special assessment against all owners to make up any deficiency for repair or rebuilding of the common area or limited common area.

Section 17. Payments by First Mortgagees First mortgagees of lots may jointly or singly pay taxes or other charges which are in default and which have or may become a charge against any common property and may pay overdue premiums on hazard insurance policies or secure new hazard insurance coverage on the lapse of a policy, for such common property. First mortgagees making such payments shall be owed immediate reimbursement therefor from the Association.

Section 18: Condemnation A first manage who has made written request including the mortgagee's name and address, and the lot number of the unit it has the mortgage on shall be entitled to receive a written notice of condemnation action that affects a malerial Molting Tooks portion of the properties, or a material portion of the unit securing its mortgage. In any proceedings, negotiations, or settlements for condemnation of all or part of the properties, the Association shall be the agent of the owners and is hereby appointed their attorney-in-fact for

such purpose. Any proceeds shall be payable to the Association for the benefit of the owners and their mortgagees, as their interests may appear. In the event the Association is required to interplead such funds, it shall be entitled to reasonable attorney's fees and costs incurred in such action.

Section 19. Management Any agreement for professional management of the property by the developer, sponsor or builder may not exceed three years' duration and must provide for termination by either party without cause and without payment of a termination fee on ninety (90) days or less written notice.

CLE V -- PARTY WALLS

- Section 1. General Rules of Law to Apply Any wall which is built as a part of the original construction upon the properties and placed on the dividing line between the lots shall constitute a party walkand, to the extent not inconsistent with the provisions of this article, the general rules of law regarding party walls and liability for property damage due to negligence or willful acts or omissions shall apply thereto.
- Section 2. Sharing of Repair and Maintenance The cost of reasonable repair and maintenance of a party wall shall be shared by the owners who make use of the wall in proportion to such use.
- Destruction by Fire or Other Casualty a party wall is destroyed or Section 3. damaged by fire or other cascialty, then, to the extent said destruction or damage is not covered by insurance and repaired out of the proceeds of the same any owner who has used the wall may restore it, and if the other wwners thereafter make use of the wall, they shall contribute to the cost of restoration thereof in proportion to such use, without prejudice, however, to the right of any such owners to call by a larger contribution from the others under any rule of law regarding liability for negligent or willful acts or omissions.
- Section 4. Weatherproofing (Notwithstanding any other provision of this article, an owner who by his negligent or wilful act causes the party wall to be exposed to the elements shall bear the whole cost of furnishing the decessary protection against such elements to the extent that said protection is not covered by insurance and paid for out of the proceeds of the same.
- Right to Contribution Runs with Fand The right of any owner to Section 5. contribution from any other owner under this article shall be appurtenant to the land and shall pass to such owner's successors-in-title.
- Arbitration In the event of any dispute arising concerning a party wall, or under the provisions of this article, each party shall choose one arbitrator, and such arbitrators shall choose one additional arbitrator within ten (10) days of their selection, and the decision shall be by a majority of all the arbitrators. Should any party refuse to appoint an arbitrator within ten (10) days merwritten request to do so, the Tostees of the Association shall select an arbitrator for the refusing party.

ARTICLE ARCHITECTURAL CONTROL COMMITTEE

No building, fence, wall or other structure shall be commenced, erected or maintained upon the properties for shall any exterior addition of change or alteration therein be there until the plans and specifications showing the nature kind, shape, height, materials, colors and location of the same shall have been submitted to and approved in writing as to harmony of external design and location in relation to surrounding structures and topography by the Trustees or, if such a committee is in existence, by an Architectural Control Committee composed of three (3) or more representatives appointed by the Trustees. ARTICLE VII -- EXTERIOR MAINTENANC

- Section 1. Exterior Maintenances Each unit owner shall be primarily responsible for maintenance to the exterior of the townhome owned and any limited common area appurtenant thereto. The Association shall, however, in addition to mathenance upon the common great have the right upon default of the Owners, after ten days written notice, to provide exterior maintenance upon each lot and limited common area, including, but not limited to the following: paint, repair, replace and care for roofs, gutters, downspouts, extenor building surfaces, fences, street signs, lights, maliboxes, trees, shrubs, grass, walks, driveways, glass, doors and screens on the lot, and maintenance to other exterior improvements
- Section 2. ARTICLE VIII -- USE RESTRICTIONS

No commercial activities of any sind whatever shall be conducted in any building or on any portion of the properties. - Section 5. - Section 10 Exterior Television or Other Antennas No exterior radio or other antennas, except one toleration antenna which shall not exceed four feet in height, per lot, shall be placed, allowed or maintained upon any lot or upon any structure or portion of the improvements stituated and located upon the properties without prior written approval and the authorization of the Trustees.

- Section 12. On any Mining Operations No oil deline oil development operations of refining, quarrying or mining operations of any kind shall be permitted upon or in the properties of any lot. No demok, lift, shart or other structure designed for use in boring for oil or natural gas shall be erected, maintained or permitted upon the properties or any lot.
- Section 13. <u>Interior Utilities</u> All utilities, fixtures and equipment installed within a lot, commencing at a point where the utility lines, pipes, wires, conduits or systems enter boundaries of a lot, shall be maintained and kept in repair by the owner thereof. ARTICLE IX -- EASEMENTS

- Section 1. Encroachments Each lot and the property included in the common and limited common areas shall be subject to an easement for encroachments created by construction, settling and overhangs, as designed or constructed by the Declarant. A valid easement for said encroachments and for the maintenance of same, so long as it stands, shall and addresses. In the event the structure containing lots is partially or totally destroyed, and then rebuilt, the owners of the lots of affected agree that minor encountering the permitted and that a wall easement for said encroachment and the maintenance thereof shall exist.
- Section 2. Utilities There is hereby created a blanket easement upon, across, over and under all of the properties for ingress, egress, limited to water, sewers, gas, telephone and electricity, and a master television antenna system. All utilities that are installed in, upon, under or through the common areas of the properties shall be maintained by the Association.
- Section 3. <u>Police. Fire and Ambulance Service.</u> An easement is hereby granted to all police, lire protection, ambulance services and all similar persons to enter upon the streets and common and limited common area in the performance of their duties.
- Section 4. Maintenance by Association Argustement is hereby granted to the Association, its officers agents, employees and to any maintenance company selected by the Association to enter in or to cross over the common and limited common areas and any lot to perform the duties of maintenance and repair.

ARTICLE X - EXPANSION

ARTICLE XI -- GENERAL PROVISIONIS

Severability All of said conditions, covenants and reservations contained in this Declaration shall be construed together, but if any one of said conditions, covenants, or reservations, or any part thereof, shall at any time be field invalid, or for any reason become unenforceable, no other condition, covenant, or reservation, or any part thereof, shall be thereby affected or impaired, and the Declarant, Association and owners, their successors, heirs and assigns shall be bound by each article, section, subsection, paragraph, sentence, clause and phrase of this Declaration, irrespective of the invalidity or unenforceability of any other article, section subsection, paragraph, sentence clause or phrase.

Section 3. Duration The covenants and restrictions of this Declaration shall run with and bind the land, and shall inugato the benefit of and be enforceable by the Association, or the owner of any lot subject to this Declaration, their respective legal representatives, here successors, and assigns to a term of twenty (20) years from the date this declaration is recorded. after which time said covenants shall be automatically extended for successive periods of ten (10) vears.

Amendment The covenants, conditions and restrictions of this Declaration may be amended by an instrument signed by not less than sixty-seven percent (67%) of the owners. Amendments affecting the rights of first mortgagees shall require their written approval Prior to making any material amendment thirty (30) days written notice must be given to all holders of liens of first priority, setting forth the nature of the amendment and the date of the members' meeting to vote thereon.



MEMBERSHIP AND VOTING RIGHTS

Section 1. Membership Every person or entity who is owner of any lot shall be a member? of the Association The ferm "owner" shall include contact purchasers but shall not include persons or entities who hold an interest merely as security for the performance of an obligation unless and until said holder has acquired title pursuant to foreclosure or proceedings in lieu of foreclosure. Membership shall be appurtenant to and may not be separated from ownership of any lot. Membership in the Association shall automatically transfer upon transfer of title by the record owner to another person or entity.

Section 2 Voting Rights The Association shall have two classes of voting membership: CLASS A. Class A members shall be all members with the exception of the Declarant and shall be entitled to one vote for each lot owned. When more than one person holds an interest in any lot, the group of such persons shall be a member. The vote for such lot shall be exercised as they among themselves determine, but in no event shall more than one vote be cast with respect to any lot. Such proof may consist of a copy of a duly executed and acknowledged warranty deed or title insurance policy showing said person, persons, entity or entities or the person nominating him qualified in accordance therewith, in which event said deed or the insurance policy shall be deemed conclusive evidence in the absence of a conflicting claim based upon a later deed or title insurance policy.

Section 4. Suspension of Membership The rights of membership are subject to the it of annual and special assessments levied by the Association. If a member fails to make the shall become due and payable the voting that the state of the sta payment of annual and special assessments levied by the association. If a member fails to make payment of any annual or special assessment levied by the Association within thirty (30) days after the same shall become due and payable the voting rights of such member may be suspended by the Board of Truštees until such assessment has been paid. Section 1. Annual Meetings The hist annual meeting of the members for the election of Trustees, the presentation of the angual mancial report of the Association and for the transaction of such other business as the Board of Trustees may determine, shall be held at such time and annual meeting of the members is a legal holiday, the meeting will be held at the same hour of the first day following which is not a legal holiday.

Section 2: Special Meetings Special meetings of the members may be called a any time by the President or by the Board of Trustees, or upon written request of the members who are entitled to vote one-fourth (1/4) of all of the votes.

Section 3. Notice of Meetings Whiten notice of each meeting of the members shall be given by, or at the direction of, the Secretary or person authorized to callithe meeting, by mailing a copy of such notice, postage prepaid, at least thirty (30) days before such meeting to each member entitled to vote thereat, addressed to the member's address last appearing on the books of the Association. Such notice shall specify the place, date and flour of the meeting, and, in the case of a special meeting the purpose of the meeting.

Section 4. Waiver of Notice The notice provided for hereinabove is not indispensable and any meeting of the members shall be deemed validly called for all purposes if all members are represented thereat in person or by proxy, or it a quorum is present and waivers of notice of time, place and purpose of such meeting shall be duly executed in writing either before or after said meeting by those members not so represented or not given such notice. The attendance of any member at a meeting in person or by proxy, without protesting prior to the meeting the lack of notice of such meeting, shall constitute a waiver of notice by him

Section 5. Quorum Except as herealter provided, and as otherwise provided in the Articles of Incorporation, the presence at the meeting of members entitled to cast, or of proxies. entified to cast, twenty percent (20%) of all the votes of each class of membership shall constitute a quorum for any action of, however, such quorum shall not be present or represented at any meeting, the members entitled to vote thereat shall have power to adjourn the meeting from time to time, without notice other than announcement at the meeting, until a quorum as aforesaid shall be present or be represented.

In case of a meeting to change the basis and maximum of assessments, to make assessments in excess of said maximum, or to levy a special assessment fixed prospectively for any applical period presence at the meeting of members, or of proxices entitled to cast sixty percent (60%) of all the votes of each class of membership shall constitute a quorum. In case of a meeting to authorize special assessments for the purpose of defraying, in whole or in part, the cost of any construction or reconstruction, repair or replacement of structures and personal property related thereunto, presence of members or of proxies of two-thirds (2/3) of all members authorized to vote shall constitute a quorum.

Section 6. Proxies At all meetings of members, each member may vote in person or by proxy. All proxies shall be in writing and filed with the Secretary prior to the receining for which the

proxy is valid. Every proxy shall be revocable and shall automatically cease upon conveyance by the member of his lot.

Section 7. Voting If a quorum is present, the affirmative vote of the majority of the members represented at the meeting shall be the act of all the members, unless the act of a greater number is expressly required by law, by the Declaration, or by the Articles of Incorporation of the Association or elsewhere in these Bylaws. Upon direction of the presiding officer, the vote upon any business before a meeting shall be by ballot, but otherwise any such vote need not be by ballot.

Section 8. Procedure The older of business and all other matters of procedure at every meeting of members shall be determined by the presiding officer.

ARTICLE V

BOARD OF TRUSTEES: SELECTION: TERM OF OFFICE

Section 1. Number The affairs of this Association shall be managed by a Board of three (3), five (5) or seven (7) Trustees, the number of persons constituting the whole Board of Trustees to be fixed from time to time by resolution of the Board of Trustees, who must be members of the Association or in the case of multiple co-owners or owners and natural persons, their designees.

Section 2 Term of Office At each annual meeting, the members shall elect Trustees for @ terms of two (2) years, with an odd number of Trustees (at least two less than the entire Board) elected in odd-numbered years and an even number of Trustees elected in even-numbered years. In the initial election of Trustees, the method of election shall provide that the term of an odd number of trustees (at least two less than the entire Board) shall expire in the next odd numbered year, and the term of an even number of trustees shall expire in the next even numbered year.

Section 3. Removal Any Trustee may be removed from the Board with or without cause. by a majority vote of the members of the Association and any Trustee who shall be absent from three (3) consecutive Board meetings shall be automatically removed from the Board unless determined otherwise by the Board. In the event of death, resignation or removal of a Trustee, a temporary successor shall be selected by the remaining members of the Board and shall serve to the unexpired term of his predecessor or until special election of a successor.

Section 4. Compensation No Trustee shall receive compensation for any service the may render to the Association. However, any Trustee may be reimbursed for his actual expenses incurred in the performance of his duties.

RTICLE VI

NOMINATION AND ELECTION OF TRUSTEE

Section 1. Nomination (Nomination for election to the Board of Trustees shall be made by: a Nominating Committee Nominations may also be made from the floor at the annual meeting of members. The Nominating Committee shall consist of a chairman, who shall be a member of the Board of Trustees, and two (2) or more members of the Association. The Nominating Committee shall be appointed by the Board of Trustees at least sixty (60) days prior to each annual meeting of the members, to serve through such annual meeting. The nominating committee shall make as many nominations for election to the Board of Trustees as it shall in its discretion determine, but Molfilojaj Colog not less than the number of vacancies that are to be filled

Section 2. Election Election to the Board of Trustees shall be by secret written ballot. At such election the members of their proxies may cast, in respect to each vacancy, as many votes as they are entitled to exercise under the provisions of the Afficies of Incorporation and these Bylaws. The persons receiving the largest number of votes shall be elected. Cumulative voting is not permitted.

ARTICLE VII

MEETINGS OF TRUSTEES

Section 1: Regular Meetings The first meeting of the Board of Trustees will follow the annual meeting of the members. Thereafter, regular meetings of the Board of Trustees shall be held at such date, time and place as may be determined from time to time by resolution of the Board of Trustees. Written holdication of each regular Board meeting shall be delivered or marked to all Trustees at least seven (7) days prior to any regular Board meeting.

Section 2. Special Meetings Special meetings of the Board of Trustees shalf be held when called by the President of the Association or by any two (2) Trustees, after not less than two (2) days' notice to each Trustee.

Section 3. Quorum A majority of the number of Trustees shall constitute a quorum for the transaction of business. Every act or decision done or made by a majority of the Trustees present at a duly held meeting at which a quorum is present shall be regarded as the act of the Board, unless a greater number is required by law, the Articles of Incorporation or these Bylaws.

Section 4: Action Without a Meeting Whenever the Trustees are required or permitted to take any action by vote such action may be taken without a meeting on written consent, setting torth the action so taken, signed by all Trustees.

ARTICLE VIII

POWERS AND DUTIES OF THE BOARD OF TRUSTEES

Section 1. Powers The Board of Trustees shall have power to:

(a) adopt and publish these and regulations governing the use of the equipment and facilities of the Association and to establish reasonable admission and other fees for the use thereof;

(b) suspend the oring rights and any other rights of a member during any period in which such member shall be in default in the payment of any assessment levied by the Association or in violation of any of the use restrictions. Such rights may also be suspended for infraction of any published rules and regulations, after notice and hearing, for a period of not to exceed sixty (60) days:

(g) levy and collect assessments as more fully outlined in the Declaration;

(h) purchase insurance as outlined in the Declaration;

(k) exercise for the Association all powers, duties and authority vested in or delegated to this Association and not reserved to the membership by other provisions of these Bylaws of the Articles of Incorporations

(I) enforce and administer the Declaration of Covenants, Conditions and Restrictions

recorded as affecting the properties.

Section 2. Duties It shall be the duty of the Board of Trustees to:

(a) act within the thirty (30) days upon any request for approval or disapproval submitted pursuant to the Declaration of Covenants Conditions and Restrictions.

(b) cause to be kept a complete record of all its acts and corporate affairs and to present a statement thereof to the members at the annual meeting of the members, or at any special meeting when such statement & equested in writing by one-traff(1/2) of the members who are entitled to vote:

(c) supervise all officers, agents and employees of this Association, and to see that their

duties are properly performed;

(d) prepare a roster of the properties and the assessments applicable thereto:

(e) fix the amount of the annual assessment against each lot at least thirty (30) days in advance of each annual assessment period:

(f), send written notice of each assessment to every owner subject thereto at least thirty

(30) days in advance of each annual assessment period;

(g) foreclose the lien against any property for which assessments are not paid within thirty (30) days after due date or bring an action at law against the owner personally obligated to pay the

(h) furnish a certificate upon demand, and for a reasonable charge, signed by an officer of the Association setting forth whether the assessment on a specified lot has been paid;

(i) maintain an adequate reserve fund for maintenance, repairs, and replacement of any elements of the common or limited common areas which must be replaced on a regular basis.

ARTICLE IX

OFFICERS AND THEIR DUTIES

Section 1. Enumeration of Offices The officers of this Association shall be a President and Vice-President, who shall at all times be members of the Board of Trustees, a secretary and a reasurer, who need not be members of the Board of Trustees from of the Association, and such other officers as the Board may from time to time create by resolution.

Section 2. Election of Officers The election of officers shall take place at the first meeting of the Board of Trustees following each annual meeting of the members.

Section 3. Jerm The officers of this Association shall be elected annually by the Board and each shall hold office for one (1) year unless he shall sooner resign, or be removed, or otherwise be disqualified to serve.

Section 4. Special Appointments The Board may elect such other officers as the affairs of the Association may require, each of whom shall hold office for such period, have such authority, and perform such deties as the Board may, from time to time, determine

Section 5. Resignation and Removal Any office may be removed from office with or without cause by the Board Any officer may resign at any time by giving notice to the Board, or any officer of the Board Such resignation shall take effect on the date of receipt of such notice or at any later time specified therein, and unless otherwise necessary to make it effective.

Section 8. Duties The duties of the officers are as follows:

(c) SECRETARY The secretary shall record the votes and keep the minutes of all meetings and proceedings of the Board and the Association together with their addresses, and

shall perform such other duties as required by the Board.

(d) TREASURER The treasurer shall receive and deposit in appropriate bank accounts all monies of the Association and disburse such funds as directed by resolution of the Board of Trustees sign all checks and promissory notes of the Association; maintain a voster of properties. assessments and payments; keep proper books of account; issue centificates of payment of assessments; cause an annual audit of the Association books to be made by an accountant at the completion of each fiscal year notify the Trustees of members who are delinquent in paying assessments and prepare an amount budget and statement of income and expenditures to be represented to the membership at its regular annual meeting and deliver a copy of the budget and statement to the members at said meeting.

Section 9. Compensation No salary or other compensation for services shall be paid to any officer of the Association for services rendered by such officer, but this shall not preclude an officer of the Association from performing any other service for the Association as an employee and receiving compensation therefor.

ARTICLE X

FINANCIAL MATTERS

Section 1. Desocitories The Board of Trustees shall select such depositories as it considers proper for the funds of the Association. All checks and drafts against such deposited funds shall be signed and countersigned by persons specified by the Board.

Section 2. Contracts: Management Contract The Board of Trustees may authorize any officer or officers, agent or agents, in addition to those specified in these Bylaws, to enter into any contract or execute and deliver any instrument in the name of or on behalf of the Association, and such authority may be general or commed to specific instances. Unless so authorized by the Board of Trustees, no officer, agention employee shall have any power or authority to bind the Association by any contract or engagement or to pledge its gradit or render it liable for any purpose or for any amount.

Section 3. Fiscal Year The fiscal year of the Association shall be determined by the Board of Trustees of the Association

Section 4. Annual Report The Board of Trustees shall present at the annual meeting of the members the report of the treasurer, giving the annual budget and a statement of income and Molfigial Color expenses, and a report of other affairs of the Association during the preceding year. The Board of

Each Trustee and officer of the Association now of hereafter serving as such shall be indemnified by the Association against any and all claims and liabilities to which he has on shall become subject white or after serving by reason of serving as Trustee or officer, or by reason of any action alleged to have been taken, omitted, or neglected by him as such Trustee or officer, and the Association shall reimburse each such person for all legal expenses reasonably incurred by him in connection with any such claim or liability; provided, however, that no such person shall be indemnified against, or be reimbursed for any expense incurred in connection with, any claim or liability arising out of his own willful misconduct or gross negligence.

COMMITTEES

Section 1. Architectural Control Committee An Architectural Control Committee composed of three or more representatives may be appointed by the Trustees.

ARTICLE XIII

CORPORATE SEA

The Association shall have a seal in a circular form having within its circumference the words "Millcreek Cottages Townhomes Association," the year of its incorporation, and a notation that the Association is Non-Profit.

ARTICLE XIV

RULES AND REGULATIONS

The Board of Trustees shall have the power to account and establish by resolution such rules and regulations as it may deem necessary for the maintenance, operation, management and control of the property, equipment, facilities and utility systems of the Association, and the Board of Trustees may after from time to time such rules and regulations. The members shall at all times obey such regulations and use their best efforts to see that they are faithfully observed by the persons with whom they reside, their lessees, invitees and others over whom they may exercise control or supervision.
