## RIGHT-OF-WAY AND EASEMENT AGREEMENT UT 19682

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, SOUTH JORDAN CANAL COMPANY is the fee simple owner of the following described tract of land situated in Salt Lake County, State of Utah, to wit:

Land of the Grantor located in the Southeast Quarter of the Southwest Quarter of Section 9, Township 2 South, Range 1 West, Salt Lake Base and Meridian, as shown on the attached drawing, designated as EXHIBIT "A", and by reference made a part hereof;

WHEREAS, QUESTAR GAS COMPANY, A Utah Corporation, is desirous of obtaining a right-of-way and easement over the property described above:

NOW THEREFORE, for value received, SOUTH JORDAN CANAL COMPANY, hereinafter referred to as Grantor, does hereby grant to QUESTAR GAS COMPANY, hereinafter referred to as Grantee, a non-exclusive right-of-way and easement over the above described real property for the purpose of laying and maintaining a 3/4" IHP steel natural gas pipeline, subject to the following restrictions, covenants and agreements:


- That prior to the construction of any crossing of that section of the right-of-way described above, drawings, plans and specifications for said crossing will be submitted to and approved by Grantor's Board of Directors.
- That Grantee, its successors in interest or assigns have the sole and continuing 2. responsibility to maintain said natural gas crossing and protect and hold harmless, Grantor, from any and all liability or loss proximately caused by the negligence of Grantee, provided, however that nothing contained herein shall make Grantee liable for loss profits or other consequential damages.

- 3. That Grantee, its successors in interest or assigns have the sole and continuing responsibility to protect against any obstruction in the flow of canal waters across or through the above described property. Further, to protect and hold harmless from any loss, damage, cause of action of any person whomsoever occasioned by any such obstruction in the flow of canal waters proximately caused by the negligence of Grantee, provided, however that nothing contained herein shall make Grantee liable for loss profits or other consequential damages.
- 4. To prevent disturbance in use of the canal, any construction contemplated by Grantee, its successors in interest or assigns must be commenced and completed during the period from October 15th through April 1st, unless written permission is obtained by Grantee, its successors in interest or assigns from the President of the South Jordan Canal Company.
- 5. Grantor and Grantee each agree that should they default in any of the covenants or agreements contained herein, that the defaulting party shall pay all costs and expenses, including a reasonable attorney's fee which may arise or accrue from enforcing this Agreement, or in pursuing any remedy provided hereunder or by the statutes of the State of Utah whether such remedy is pursued by filing suit or otherwise.
- 6. It is understood that this Agreement constitutes the entire agreement between the parties and shall not be altered or modified by any prior or subsequent oral agreements, except as mutually agreed in Articles 1 through 5.




