ARTICLES OF AMENDMENT

TO THE

DECLARATION OF PLANNED UNIT DEVELOPMENT

AND

DECLARATION OF COVENANTS, CONDITIONS AND RESTRICTIONS

FOR

GATEWAY TOWN HOMES
A RESIDENTIAL PLANNED UNIT DEVELOPMENT PROJECT

IN

SALT LAKE CITY, UTAH

Article 7 of the Declaration of Planned Unit Development and Declaration of Covenants, Conditions and Restrictions for Gateway Town Homes, recorded as Entry Number 6767927 at Book 7785 Pages 2867-2927, in the books and records of the Salt Lake County Recorder is hereby amended as follows:

- 7.7 Acceleration of Assessment Installments Upon Default. If a unit owner shall be in default in the payment of an installment upon an assessment, the Board of Directors or the Management Committee may accelerate the remaining installments of the assessments upon notice thereof to the unit owner, and thereupon the unpaid balance of the assessment shall come due upon the date stated in the notice, but not less than ten (10) days after delivery thereof to the unit owner, or not less than twenty (20) days after the mailing of such notice to him by regular mail.
- 7.8 Continued Default. In such event, a unit owner, for more than twenty (20) days after mailing of notice provided in Section 7.7 above, shall be taxed in addition to such assessment an additional penalty of\$5.00 for each and every day that said assessment shall remain unpaid. In lieu of the above, the Board of Directors may proceed in accord with any other remedies according by the laws of Utah. In any proceeding by the Board, it shall be entitled to recover all costs together with a reasonable attorney fee.
- 7.9 Utility Service. Right of Access and Use. If a unit owner shall be in default in the payment of an installment upon an assessment, the Board of Directors may terminate utility services paid as a common expense. Before terminating utility services, the manager or Board of Directors shall give written notice to the unit owner in the manner provided in Subsection 7.7. The notice shall inform the owner: (a) that utility service will be terminated if payment of the assessment is not received within the time provided in Subsection 7.7; (b) of the amount of the assessment due, including any interest or late payment fee; and (c) the right to request a hearing.

A unit owner, who is given notice as set forth above, may request an informal hearing to dispute the assessment by submitting a written request to the Board of Directors within fourteen (14) days after the date on which the owner receives said notice. The hearing shall be conducted by the Board of Directors in accordance with the standards provided by the American Arbitration Association. If a hearing is requested, utility services or right of access and use of recreational facilities may not be terminated until after the hearing has been conducted and a final decision has been entered.

Upon payment of the assessment due, including any interest or late payment fee, the manager or Board of Directors shall immediately take action to reinstate the terminated utility services.
