A strip of lend two (2) rods in width (one rod on each cide of the existing pipe line) running a distance of approximately twelve and one-half (12%) rods north and couth, across the west end of the following doscribed portion of said premises, to-wit:

Commoneing at a point on the south line of lot 2, Section 14, Township 1 North, Range 1 West, Salt Lake Base and Meridian; on the west side of where the Rio Grande Western Railway intersections the south line of said Lot 2; thence north on the west side of said Denver and Rio Grande Western Railroad Company's land twelve and one-half (123) rods; thence west to the Edutorn shore of Hot Springs Lake; thence south twelve and one-half (123) rods; thence east to the place of a beginning.
