4501 South 2700 West, Salt Lake City, Utah 84119, Grantee, for the sum  
of Ten (\$10.00) Dollars,

A perpetual easement upon part of an entire tract of property located in Section 31, Township 4 South, Range 2 East, Salt Lake Base and Meridian, Utah County, for the purpose of constructing thereon a signal facility and appurtenant parts thereof incident to the improvements to the intersection of 11000 North (SR-92) and 4800 West in Highland Utah, known as project no. SP-9999(466).

The boundaries of said part of the entire tract are described as follows:

Beginning at the Northwest corner of said part of an entire tract, said corner being 15.063 meters perpendicularly distant southerly from the centerline of said project at Engineer Station 2+145.71, said corner also being 413.550 meters South 0°04'50" West and 11.206 meters East from the Northwest corner of said Section 31; and running thence  
North 89°36'59" East, a distance of 3.827 meters; thence  
South 0°23'02" East, a distance of 1.430 meters; thence  
South 89°36'59" West, a distance of 3.827 meters; thence  
North 0°23'02" West, a distance of 1.430 meters to the point of beginning as shown on the official map of said project on file in the office of the Utah Department of Transportation. The above described parcel of land contains approximately 5.473 square meters.
