Defendant has failed to plead or otherwise defend in this action and default has been entered.

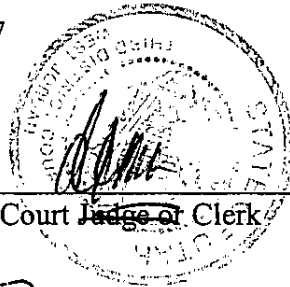

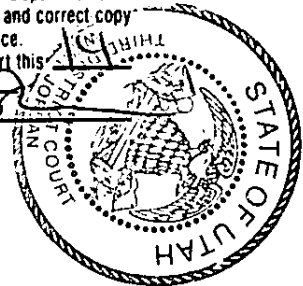


