as party of the first part and The Laytona Town, a corporation,  
as party of the second part. WITNESSETH: 303

In consideration of the payment by party of the second part to party of the first part of the sum of One Dollars, receipt of which is hereby acknowledged, party of the first part hereby grants unto party of the second part, its successors and assigns, the right, privilege and authority to construct, operate and maintain a pipe-line from the Mouth of Middle Fork Canyon above the Mountain Road to Kays Creek Irrigation Company's Reservoir (Known as Hobbs Reservoir), said pipe line to follow the old channel of Middle Fork.

Party of the first part makes this grant as far as the Middle Fork Channel runs through their property. It is mutually understood and agreed that said party of the second part may have the right to enter upon said premises for the purpose of making repairs or alterations upon said pipe-line.
