

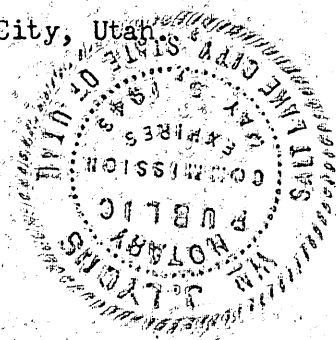

(UTAH CORPORATION)

75. State Bank of Lehi a corporation doing business in the State of Utah, Grantor, hereby conveys, and warrants to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission, distribution, telephone and telegraph circuits of the Grantee, and two two pole towers and no guy anchors with the necessary guys, stubs, cross arms, braces and other attachments affixed thereto, for the support of said circuits, on, under, over, through, and across a tract of land (50) feet in width, located in Utah County, Utah, and being twenty-five (25) feet on each side of the following described center line:

Beginning at fence on north boundary line of grantor's land at a point 2640 feet south and 260 feet east, more or less, from the north quarter corner of Section 35, T. 4 S., R. 1 W., S.L.B. & M., thence running S. 18°33'E. 1406 feet to fence on south boundary line of said land and being in the NW 1/4 of the SE 1/4 of said Section 35.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.

Beginning at fence on north boundary line of Grantor's land at a point 220 feet south and 125 feet east, more or less, from the west quarter corner of Section 18, T. 5 S., R. 1 E., S.L.B. & M., thence running S. 65°19' E. 100 feet, more or less, to east boundary line of Grantor's land at west fence line of County Road and being in the NW 1/4 of the SW 1/4 of said Section 18.
