doing business in the State of Utah, Grantor, hereby conveys and warrants to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution, and telephone circuits of the Grantee, and one guy anchor and one pole, with the necessary guys, stubs, cross-arms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained upon and across the premises of the Grantor, in Summit County, Utah along a line described as follows:

Beginning at an existing pole on the Grantors' land at a point 1610 feet north and 615 feet east, more or less, from the south one quarter corner of Section 27, T. 1 N., R. 7 E., S.L.M., thence S. 82° 02' W. 270.4 feet, thence N. 75° 40' W. 359.6 feet to the west boundary fence on said land and being in the NW 1/4 of the SE 1/4 of said Section 27.
