AMENDMENT TO THE DECLARATION OF EASEMENTS, COVENANTS, CONDITIONS AND RESTRICTIONS

SLEEPY RIDGE A PLANNED RESIDENTIAL DEVELOPMENT

- A. Certain real property in Utah County, Utah, as described below, is subjected to certain covenants, conditions and restrictions pursuant to a Declaration of Easements, Covenants, Conditions and Restrictions recorded December 13, 2004, as Entry No. 139465:2004 in the Recorder's Office for Utah County, Utah (the "Declaration").
- B. This amendment shall be binding against the property subjected to the Declaration and any annexation or supplement thereto, further as described in **Exhibit A** and **Exhibit B** attached hereto:
- C. In order to provide for the separation of the properties listed above and governed by the Sleepy Ridge Property Owners' Association ("Association") into two separate and distinct owner associations, the Association deems it necessary and in the best interests of the Members to adopt the following amendments.
- D. Pursuant to Article XIV, Section 14.02 of the Declaration, the undersigned hereby certifies that the voting requirements to amend the Declaration have been satisfied to adopt this Amendment.

NOW, THEREFORE, the Association hereby amends **Article III** of the Declaration by adding the following entirely new Section 3.07:

3.07 Separation of Subdivision into Two Distinct Homeowners Associations.

Effective July 1, 2020, the Sleepy Ridge Property Owners' Association ("Association" or "Existing Association") shall have the authority to separate into two separate homeowner associations. The separate HOAs will be known as:

- a. Fairway on the Links, with legal description as shown on Exhibit A, and
- b. Sleepy Ridge HOA, with legal description as shown on Exhibit B,

provided that:

- (1) The Board of Directors of the Existing Association ("Board") shall have the authority to establish Separation Terms, including but not limited to the equitable distribution of funds, including reserves, and ownership/use/maintenance of amenities and roads, and that:
- (2) The newly formed Fairways on the Links will be responsible to draft and manage all governing documents that will pertain to its association.
- (3) Once the decision to separate has been made, Fairways on the Links homes will still be part of Sleepy Ridge HOA until new governing documents have been drafted and recorded.
- (4) What will be known as Sleepy Ridge HOA, with legal description as shown on Exhibit B, will continue to operate under the existing Governing Documents.
- (5) The Board shall be authorized to execute and record all necessary documents to terminate the governing documents of the original Association as contemplated herein, including changes with legal descriptions as set forth in Exhibits A and B attached hereto, including changes.
- (6) The separation anticipated by this amendment shall be effective upon the recording of the governing documents for Fairway on the Links and the termination and amendments required by paragraph (5) above.
- (7) A copy of this amendment shall be properly recorded in Utah County against all properties now included in the Existing Association upon its approval.
