**SIXTH AMENDMENT TO DECLARATION OF ESTABLISHMENT OF BASIC
PROTECTIVE RESTRICTIONS, LIMITATION, CONDITIONS, COVENANTS,
RESERVATIONS, LIENS, AND CHARGES
FOR
CITYCREST CONDOMINIUM**

This Sixth Amendment to Declaration of Establishment of Basic Protective Restrictions, Limitations, Conditions, Covenants, Reservations, Liens, and Charges for CityCrest Condominium is made and executed by the CityCrest Homeowners Association, Inc. of 131 East First Avenue, P. O. Box 102, Salt Lake City, UT 84103 (the "Association").

RECITALS

A. The Declaration of Establishment of Basic Protective Restrictions, Limitations, Conditions, Covenants, Reservations, Liens, and Charges for CityCrest Condominium was recorded in the office of the County Recorder of Salt Lake County, Utah on December 13, 1978 as Entry No. 3167371 in Book 4738 at Page 912 of the official records (the "Declaration").

B. This document affects the real property located in Salt Lake County, Utah, described with particularity on Exhibit "A," attached hereto and incorporated herein by this reference (the "Property").

C. All of the voting requirements of Article XIV(a) of the Declaration to amend the Declaration have been satisfied.

D. The Association is the managing agent of the Owners of the Property.

E. The voted to adopt a non-smoking policy and amend the Declaration.

NOW, THEREFORE, for the reasons recited above, and for the benefit of the Project and the Unit Owners thereof, the Association hereby executes this Amendment to Declaration of Condominium for CityCrest Condominium for and on behalf of and for the benefit of all of the Unit Owners.

1. The Declaration is hereby amended to add the following new Article:


Article XI - SMOKING

Smoking. Smoking is not permitted at CityCrest, neither in the Units nor in the Common Area or within twenty-five feet (25') of the Building. Smoking in violation of this section shall be considered a nuisance. For use herein, a nuisance is anything which is injurious to health, indecent, offensive to the senses, or an obstruction to the free use of property, so as to interfere with the comfortable enjoyment of life or property. A nuisance includes tobacco smoke that drifts into any Unit from Unit or the Common Area and this smoke: (a) drifts in more than once in each of two or more consecutive seven-day periods; and (b) creates any of the conditions of nuisance.

2. The effective date of this Amendment is the date it is recorded in the office of the County Recorder of Salt Lake County, Utah.
