## 1 ASSIGNMENT OF INTEREST IN OIL AND GAS LEASE

10 have sold, and by these presents do bargain, sell, assign, transfer, and set

12 husband and wife, as joint tenants with full rights of survivorship, and not as  
13 tenants in common, all the right, title, and interest of the undersigned  
14 assignors in, to, and under that certain oil and gas lease bearing date the
