Except for Certified Service Dogs where such dog is essential to a visually impaired person entering or living in the Carlton Towers, a unit owner shall not permit any animals of any kind to be raised, bred, or kept in his/her unit or in the common areas and facilities appurtenant to his/her unit, except as a three-fourths (3/4) majority of unit owners voting at an annual meeting of the association may decide otherwise.

Section 22.6. In assessing the unit owners for capital improvements to the common areas and facilities, for which there are not sufficient amounts in the respective capital accounts, there shall be no single improvement exceeding the sum of two times the aggregate monthly assessment of all unit owners made by the management committee without the same having been first voted on and approved by a two-thirds (2/3) majority of those present in person or by proxy of the association at a meeting duly called for that purpose. The foregoing shall not apply in connection with damage or destruction referred to in paragraph 13 hereof or to such structural alterations, capital additions to or capital improvements of the common areas and facilities as are necessary in the management committee's reasonable judgment to preserve or maintain the integrity of the common areas and facilities of the property.
