A RESOLUTION DESIGNATING AN ASSESSMENT AREA TO BE KNOWN AS THE "NORTH RANCH SPECIAL ASSESSMENT AREA "NORTH (THE RANCH ASSESSMENT AREA"); GENERALLY AS DESCRIBED IN THE NOTICE OF INTENTION DESIGNATING THE **PROPOSED ASSESSMENT** AREA: AUTHORIZING THE CITY OFFICIALS TO PROCEED WITH THE ACQUISITION AND CONSTRUCTION OF THE IMPROVEMENTS AS SET FORTH IN THE NOTICE OF INTENTION; AND RELATED MATTERS.

WHEREAS, pursuant to the Assessment Area Act, Title 11, Chapter 42, Utah Code Annotated 1953, as amended (the "Act"), on August 19, 2008, the City Council of the City of Eagle Mountain, (the "City"), adopted a Notice of Intention (the "Notice of Intention") to designate a special assessment area to be known as the "North Ranch Special Assessment Area 2008-2" (the "North Ranch Assessment Area"), and after giving notice as required by the Act, held a public hearing on September 16, 2008, at which interested persons, if any, were heard concerning comments or protests relating to said North Ranch Assessment Area; and

WHEREAS, pursuant to Section 11-42-206 of the Assessment Area Act, and consistent with the Notice of Intention, the Council now desires to designate the "North Ranch Special Assessment Area 2008-2":

BE IT RESOLVED by the City Council of the City of Eagle Mountain, Utah, as follows:

- Section 1. The Council has determined it will be in the best interest of the City to finance the costs of the acquisition of certain infrastructure improvements consisting of extension of the natural gas mainline, and the installation and connection of certain lateral natural gas lines, as well as other miscellaneous work necessary to complete the improvements (collectively, the "Improvements") and to complete the whole in a proper and workmanlike manner according to plans on file in the office of the City of Eagle Mountain, Utah, as generally described in the Notice of Intention adopted by the Council on August 19, 2008, with respect to the designation of the "North Ranch Special Assessment Area 2008-2."
- Section 2. The estimated costs of Improvements are hereby authorized and the North Ranch Assessment Area is hereby designated to finance the acquisition and construction of the Improvements and to levy assessments to pay said costs of Improvements.
- Section 3. The legal description and tax identification numbers of the properties anticipated to be assessed within the North Ranch Assessment Area are set forth in Exhibit A attached hereto.

Section 4. As required by law, the City Recorder is hereby authorized and directed to file in the County Recorder's office within fifteen (15) days from the date hereof (a) a copy of the Notice of Intention, a copy of which is attached hereto as Exhibit C and an original or certified copy of this Resolution designating the North Ranch Assessment Area, and (b) a Notice of Proposed Assessments in substantially the form of Exhibit D hereof which states that the City Council has designated the North Ranch Assessment Area and which lists the properties proposed to be assessed, described by tax identification number and legal description.
