Declarant is the "Declarant" under and pursuant to each of the previously-recorded Declarations of Covenants, Conditions, and Restrictions and Reservation of Easements for Apple Hollow Plat A (each a "**Declaration**" and collectively the "**Declarations**") which Declarations are each recorded in the Official Records of the Utah County Recorder as follows: (i) Declaration dated May 14, 2010 and recorded May 21, 2010 as Entry 42030:2010; (ii) Declaration dated May 14, 2010 and recorded June 11, 2010 as Entry 48263:2010; (iii) Declaration dated March 2, 2011 and recorded March 9, 2011 as Entry 19441:2011; (iv) Declaration dated August 18, 2013 and recorded September 4, 2013 as Entry 84629:2013; (v) Declaration dated August 12, 2014 and recorded November 24, 2014 as Entry 84866:2014; (vi) Declaration dated September 17, 2015 and recorded February 11, 2016 as Entry 11473:2016; and (vii) Declaration dated January 19, 2017 and recorded February 23, 2017 as Entry 18500:2017.
- B. This Modification is made pursuant to Declarant's rights of annexation under each Declaration.
- C. In addition to the Original Property identified in and subject to each Declaration and the Declarations collectively, Declarant (and/or an affiliate of Declarant) owns additional real property in the City of Santaquin, Utah County, Utah, that Declarant desires to add to the Annexable Property as that term is defined and as that property is currently identified in the Declarations.
- D. The Declarations erroneously previously identified as Annexable Property certain portions of the Original Property already included in and subject to the Declarations.

- E. Pursuant to what is identified as Article IX in most of the Declarations (but in any case, the section titled "Right of Annexation" in each Declaration), Declarant may unilaterally supplement or modify by recorded instrument the description of the Annexable Property described in Exhibit "B" of the Declarations.
- F. Declarant desires to exercise said right and to delete the Exhibit "B" of each of the Declarations and to replace said exhibit with a description of the additional property owned by Declarant thus modifying the Annexable Property subject to the Declarations as more fully set forth herein.

NOW, THEREFORE, in consideration of the foregoing, Declarant hereby supplements and modifies the Annexable Property under the Declarations as follows:

- 1. <u>Modification</u>. Exhibit "B" of the Declarations is hereby deleted in its entirety and replaced with <u>Exhibit "B"</u>, attached hereto and incorporated herein by this reference. Notwithstanding any other provisions in the Declarations to the contrary, from and after the date of the recording of this Modification in the Official Records of the Utah County Recorder, all references to the Annexed Property shall mean and refer to the property described in <u>Exhibit "B"</u> attached hereto.
- 2. <u>Effect of Modification of Declarations</u>. This Modification supersedes all prior recorded documents affecting the property subject to the Declarations. To the extent any provisions of this Modification modify or conflict with any provisions of the Declarations, including prior addenda, amendments, schedules and exhibits, the terms of this Modification shall control.
- 3. <u>Capitalized Terms</u>. All capitalized terms used and not otherwise defined herein shall have the meanings set forth in the Declarations.
- 4. <u>Effective Date</u>. This Modification will take effect on the date this it is recorded at the office of the Utah County Recorder.


