Parcel No. 1:

That portion of Lot 33, MOUNT OLYMPUS SPLENDOR, a subdivision, the official plat of which was recorded February 1, 1980 as Entry No. 3395154, in Book "80-2" of Plats, at Page 25, of the Official Records of the Salt Lake County Recorder, more particularly described as follows: Beginning at the Northeast corner of said Lot 33, and running thence South 1°28' East 98.58 feet; thence South 9°52' West 24.33 feet to the Northerly line of the Salt Lake Aqueduct Tract; thence Northwesterly along said Salt Lake Aqueduct Tract to a point North 77°00' West 161.32 feet from the point of beginning; thence South 77°00' East 161.32 feet to the point of beginning.

Parcel No. 2:

A non-exclusive Easement for purposes of ingress and egress, appurtenant to Parcel 1 described herein, granted in that certain Special Warranty Deed recorded May 4, 1982 as Entry No. 3672162, in Book 5368, at Page 1409 of the Official Records of the Salt Lake County Recorder, pursuant to the provisions of that certain Contract and Grant of Easement recorded February 1, 1980 as Entry No. 3395153, in Book 5039, at Page 81 of the Official Records of the Salt Lake County Recorder, over that part of the Salt Lake Aqueduct Tract within Lot 33, Mount Olympus Splendor, a subdivision, according to the official plat thereof filed in the Official Records of the Salt Lake County Recorder, described as follows: Beginning at a point North 77°00' West 161.32 feet from the Northeast corner of said Lot 33, and running thence North 77°00' West 54.26 feet; thence South 36°50' East 12.85 feet to a point of curve; thence Southerly 57.92 feet along the arc of a 90.10 foot radius curve to the right, then center of said curve bears South 53°10' West to a point of tangency; thence South 133.71 feet: thence East 178.03 feet: thence North 9°52' East 27.40 feet to the Northerly line of the Salt Lake Aqueduct Tract; thence Northerly and Northwesterly along the Northerly line of said Salt Lake Aqueduct Tract to the point of beginning.
