SECOND AMENDMENT TO THE BYLAWS OF CARRIAGE HOUSE CONDOMINIUMS

(the "Association") is a Utah non-profit corporation, which was created by the *Condominium Declaration for Carriage House Condominiums* on August 10 1988, recorded in the Summit County Recorder's Office at Entry No. 295098 ("Declaration");

WHEREAS the Bylaws ("Bylaws") for the Association were attached to the recorded Declaration;

WHEREAS the Association caused the first amendment to the Bylaws, entitled "Bylaw Amendment Election Process," to be recorded in the Summit County Recorder's Office on December 4, 2017 at Entry No. 1082585 ("First Amendment"), and is binding on all Unit Owners within the Association

WHEREAS the Association desires to amend the Bylaws to allow the majority of the Board of Trustees to take action without a meeting, as allowed under the Utah Non-Profit Corporations Act;

WHEREAS, this amendment was made by the required majority of the Board of Trustees, pursuant to Article XII of the Declaration;

THEREFORE, the Association hereby makes the following amendment to its Bylaws:

AMENDMENT ONE

Article IV. Section 4.09 of the Bylaws is hereby amended and replaced in its entirety, to read as follows:

"4.09 Acting Without a Meeting. Any action required or permitted to be taken by the Board of Trustees may be taken without a meeting if the majority of the members of the Board of Trustees shall individually or collectively consent in writing to such action. The meeting minutes of the proceedings of the Board of Trustees shall reflect that such written consent(s) were given."
