IT IS HEREBY ORDERED, ADJUDGED AND DECREED:

1. Plaintiff is awarded judgment against Defendants BILL BAILEY and SUNDAY TARYON in the principal amount of **\$1,703.11**, together with accrued interest at **14.650%** from March 14, 2009, through October 30, 2009 in the amount of **\$157.22** on Note I.

2. Plaintiff is awarded judgment against Defendants BILL BAILEY and SUNDAY TARYON in the principal amount of **\$4,151.97**, together with accrued interest at **11.336%** from July 15, 2009, through October 30, 2009 in the amount of **\$137.98** on Note II.

3. Plaintiff is awarded its costs and disbursements incurred in this action, amounting to the sum of **\$213.50**. Attorney's fees are awarded in the amount of **\$395.00**, pursuant to the written agreement between the parties and consistent with the Affidavit of Attorney's Fees filed contemporaneously herewith. The total judgment, including the principal judgment, interest, costs, and attorney's fees is **\$6,758.78**.


