In addition, the Property shall be subject to the governance of Soda Row Townhome Association, Inc., a Utah nonprofit corporation, as more particularly described in the Declaration.

- 4. <u>Incorporation by Reference</u>. The Recitals and Exhibit to this Supplement are hereby incorporated into this Supplement by this reference.
