By application filed on June 26, 2020, and serialized UTU-94842-01, the State of Utah has selected by Quantity Grant the following described lands in partial satisfaction of a grant made to the State of Utah for an Agricultural College pursuant to the Utah Enabling Act (Act of July 16, 1894, 28 Stat. 107 § 8), and in accordance with the regulations contained in 43 CFR 2400. This action is also being taken pursuant to Section No. 1005 of the John D. Dingell, Jr. Conservation, Management, and Recreation Act of 2019, (Public Law 116-9).

### Salt Lake Meridian, Utah

T. 6 S., R 1 W.

sec. 8, lots 3, 4, 7, and 8, SW1/4NE1/4, E1/2NW1/4, NE1/4SW1/4, and W1/2SE1/4; sec. 10, E1/2NE1/4.

The areas described aggregate 483.2 acres in Utah County, Utah.

The selected lands have been found to be subject to selection, being surveyed unreserved lands of the United States, are free from adverse claims of record, and have been classified as suitable for selection by the State of Utah and open to disposition in accordance with the provisions of Section 7 of the Taylor Grazing Act, as amended (43 U.S.C. 315f).

Therefore, pursuant to the Delegation of Authority, Bureau of Land Management Manual 1203 of October 19, 2019, this list embracing 483.2 acres for all right, title and interest is hereby approved subject to valid existing rights at the date of selection.

EXCEPTING AND RESERVING TO THE UNITED STATES a right-of-way thereon for ditches and canals constructed by the authority of the United States pursuant to the Act of August 30, 1890 (43 U.S.C. 945).

### SUBJECT TO:

1. Those rights for an overhead 345 kilovolt transmission line right-of-way UTU-95958, issued pursuant to the Act of October 21, 1976, to PacifiCorp dba Rocky Mountain Power for a perpetual term.

- 2. Such rights as grazing permittee, Foster Livestock LLC (transferred from Gerald T. and Jeannie Roundy), may have to continue livestock grazing use authorized by permit number 4301103, through the period of November 20, 2023.
- 3. Such rights as grazing permittees, W. Glade Berry and Sons, may have to continue livestock grazing use authorized by permit number 4303562, through the period of August 29, 2024.

Upon expiration or termination of these authorizations, such rights will automatically vest with the State, and new authorizations will be negotiated with the State of Utah.

The area heretofore certified under this grant together with the land included in this list, aggregates 483.2 acres.
