To enable the Utah Department of Transportation to construct and maintain a public highway as a freeway, as contemplated by Title 72, Chapter 6, Section 117, Utah Code Annotated, 1998, as amended, the limited access highway facility that will comprise of frontage roads and adjacent lands between the frontage roads for a future limited access highway, the Owners of said entire tract of property hereby release and relinquish to the Utah Department of Transportation any and all rights of ingress and egress from Owner's remaining property adjacent to the land, which consists of the limited access highway facility, conveyed to the Utah Department of Transportation, **EXCEPTING** and reserving to said Owners, their successors or assigns, the right of access for the purpose of a dedicated city street to said frontage roadway known as MP-0182 at a points directly opposite Easterly from Engineer Stations 1052+18.14 and 1064+36.58; and **PROVIDED**, however, that such remaining property of said Owners shall abut upon and have access to said frontage roads which will be connected with said inner through traffic lanes only at such interchange points as may be established by public authority.

A parcel of land, in fee for a highway known as Project No. MP-0182(6), being part of an entire tract of property, situate in the NW¼NW¼, SW¼NW¼ and the NW½SW¼ of Section 6, T. 4 S., R. 1 W., S.L.B. & M. The boundaries of said parcel of land are described as follows:

Beginning in the easterly boundary line of the Foothills Plat, recorded as Entry No. 3424598, in Book 80-4, at Page 72 in the Office of the Salt Lake County Recorder. which point is 45.00 ft. S. 0°26'28" E. along the section line from the Northwest Corner of said Section 6; and running thence S. 89°48'48" E. 786.93 ft. to a point 62.83 ft. perpendicularly distant southerly from the 13400 South Street Right of Way Control Line, opposite approximate Engineer Station 26+00.77; thence S. 0°21'29" E. 15.62 ft. along the easterly boundary line of said entire tract; thence N. 89°46'40" W. 76.74 ft.; thence S. 78°43'37" W. 195.01 ft. to a point 266.64 ft. perpendicularly distant easterly from the Mountain View Right of Way Control Line, opposite approximate Engineer Station 1078+01.33; thence S. 5°55'18" W. 257.76 ft.; thence S. 0°26'26" E. 943.66 ft.; thence Southwesterly 412.74 ft. along the arc of a 15,241.00 ft. radius curve to the right (Note: Chord to said curve bears S. 0°20'07" W. for a distance of 412.73 ft.); thence S. 3°20'26" W. 400.51 ft.; thence S. 0°26'26" E. 1,625.88 ft.; thence Southerly 276.48 ft. along the arc of a 4,480.00 ft. radius curve to the left (Note: Chord to said curve bears S. 2°12'31" E. for a distance of 276.43 ft.) to the southerly line of said NW1/4SW1/4 of said Section 6 at a point 220,00 ft, radially distant easterly from said control line opposite approximate Engineer Station 1038+67.05; thence along said southerly line S. 89°59'41" W. 103.93 ft.; thence N. 0°26'17" W. 364.23 ft. (361.50 ft. record); thence S. 89°33'43" W. 362.62 ft. (361.50 ft. record) to the westerly line of said Section 6, at a point 238.01 ft. perpendicularly distant westerly from said control line opposite approximate Engineer Station 1042+45.84; thence N. 0°26'25" W. 977.13 ft. along said westerly line, to the West Quarter corner of said Section 6; thence along said westerly line, N. 0°26'28" W. 2,632.16 ft. to the point of beginning as shown on the official map of said project on file in the office of the Utah Department of Transportation. The above described parcel of land contains 1,758,480 square feet in area or 40.369 acres, more or less.

(Note: Rotate all bearings in the above description 0°14'52" clockwise to match the above said Right of Way Control Line.)
