- 2. Borrower promises to pay the Unpaid Principal Balance, plus interest, to the order of Lender. - 7. That I will execute such other documents as may be reasonably necessary to either (i) consummate the terms and conditions of this Agreement; or (ii) correct the terms and conditions of this Agreement if an error is detected after execution of this Agreement. I understand that either a


