## SECOND AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS & RESTRICTIONS FOR SANDY POINT NO. 2 P.U.D.

A Planned Residential Development

This Second Amendment to the Declaration of Covenants, Conditions and Restrictions and By-Laws (hereafter referred to as the "Governing Documents") is made and executed this 13<sup>th</sup> day of October, 2009, by members of the Sandy Point No. 2 P.U.D. Homeowners Association (hereafter referred to as the "Association").

## **RECITALS:**

- A. This Second Amendment to the Governing Documents affects that certain real property located in Salt Lake County, Utah described with particularity in Exhibit "A" attached hereto and incorporated herein by this reference (hereafter referred to as the "Tract").
- B. Declarant is the Association as described in Section 1.3 of the CC&Rs.
- C. The Association is the owner of all of the Common Area and Facilities in the Tract.
- D. Declarant intends to amend the Section 10 of the CC&Rs to have five (5) Members on the Management Committee.
- E. Declarant intends Section 10.a through 10.f remain the same.
- F. Declarant intends to amend the By-Laws Article IV Section 1 to designate the Officers of the Management Committee to include a Vice-Treasurer.
- G. Declarant intends to amend the By-Laws to create the position of Vice-Treasurer and the duties of the Vice-Treasurer.

## **DECLARATION**

NOW, THEREFORE, for the reasons recited above and subject to the Governing Documents set forth below, Declarant hereby make the following Second Amendment to the Declaration:

- 1. The Declaration is hereby amended so that Section 10 of the CC&Rs reads: "10. Management Committee. The Association shall be managed by a Management Committee which shall be comprised of five (5) members. All Members shall be elected for two (2) year terms."
- 2. The Declaration is hereby amended so that Section 11.e is added to read: "Vice Treasurer. The Vice Treasurer shall assist the Treasurer in all the duties of the Treasurer and function as the Treasurer whenever the Treasurer is unable for any reason to perform their duties. The Vice Treasurer shall become the Treasurer should the Treasurer be removed from the Committee or cease to function as the Treasurer."

- Article IV Section 1 of the By-Laws of the Association shall be amended to designate that the Management Committee will consist of a President, Vice-President, Secretary, Treasurer, and Vice-Treasurer all of whom shall be elected by the Committee.
- Add Article IV Section 8 to the By-Laws of the Association to read: "Vice
