## SEVENTH AMENDMENT TO THE DECLARATION OF COVENANTS, CONDITIONS & RESTRICTIONS FOR SANDY POINT NO. 2 P.U.D.

A Planned Residential Development

This Seventh Amendment to the Declaration of Covenants, Conditions and Restrictions (hereafter referred to as the CC&Rs) and By-Laws (jointly hereafter referred to as the "Governing Documents") is made and executed this 1<sup>st</sup> day of November, 2009, by members of the Sandy Point No. 2 P.U.D. Homeowners Association (hereafter referred to as the "Association").

## **RECITALS:**

- A. This Seventh Amendment to the Governing Documents affects that certain real property located in Salt Lake County, Utah described with particularity in Exhibit "A" attached hereto and incorporated herein by this reference (hereafter referred to as the "Tract").
- B. Declarant is the Association as described in Section 1.3 of the CC&Rs.
- C. The Association is the owner of all of the Common Area and Facilities in the Tract.
- D. The Association is empowered to amend the Declaration as described in Section III.29.a of the CC&R's.
- E. Declarant intends to amend the Governing Documents to allow the use of legal fireworks on Members property.
- F. Declarant intends to amend the Governing Documents to require Members to clean up any fireworks and/or the waste product of such fireworks used on their property.
- G. Declarant intends to amend the Governing Documents to restrict the use of fireworks in, on or about any common area including the street.
- H. Declarant intends to amend the Governing Documents to restrict the use of fireworks to certain hours and days.

## **DECLARATION**

NOW, THEREFORE, for the reasons recited above and subject to the Governing Documents set forth below, Declarant hereby makes the following Seventh Amendment to the Declaration:

- 1. The Declaration is hereby amended to add Section III.5.f.(6).a to read: "Legal fireworks are allowed within the Project subject to rules adopted by the Committee. Such fireworks must be of a type approved by the State of Utah and any subdivision thereof."
- 2. The Declaration is hereby amended to add Section III.5.f.(6).b to read: "Fireworks are restricted to the users property and shall not be used in, on or around Common Area. Common Area is defined to include the street."
- 3. The Declaration is hereby amended to add Section III.5.f.(6).c to read: "Fireworks shall only be used between the hours of 6:00 p.m. and 10:00 p.m. on the specific date of

the celebration. Fireworks shall not be used before or after the specific date. The specific date does not include the Statute allowed three (3) days before and after the specific holiday date."

- 4. The Declaration is hereby amended to add Section III.5.f.(6).d to read: "Lot owners shall clean up any debris, waste product or concrete disfiguration or coloring resulting from the use of fireworks immediately following their use. There shall be no evidence that fireworks were used after cleaning up."
- 2. This amendment shall be effective the date it is recorded in the office of the County Recorder of Salt Lake County, Utah.
