"The Committee shall be composed of five (5) members who are Unit Owners in Cornerstone Condominiums Homeowners Association and elected as provided in the Bylaws. Effective March 2010 officers will serve for a three (3) year term. Beginning March 2011 the replacement officers will be elected for three (3) year terms. This allows a carryover of two (2) years for either one or two officers.







At least six (6) weeks prior to each annual Meeting of the Unit Owners, the Management Committee shall select from the Unit Owners a Nominating Committee. See Article 11 Below for details.


