
GRANT DEED

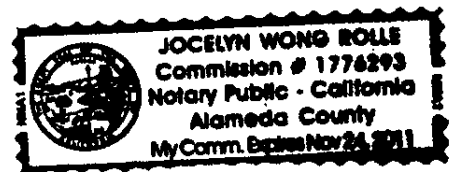
