## **RECITALS**

- B. Hawkins, are the owners of that certain real property (Hawkins) 1362 East Vine Street, Salt Lake City, UT 84121. The legal description of the Hawkins is attached hereto as Exhibit "B" and by this reference made a part thereof.
- C. There is a common wall constituting the boundary between the Knight property and the Hawkins.
- D. The parties desire to enter into an agreement regarding the use and maintenance and repair of the common wall.

NOW THEREFORE, in consideration of the premises, covenants and promises made herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

- 1. The parties agree to maintain the common wall in good condition and repairs.
- 2. Should the common wall between the Knight property and the Hawkins, property at any time be damaged or destroyed by the default or negligence of one of the parties, the party who causes the damage or destruction shall rebuild or repair said wall to a condition equal to or better that its condition immediately prior to its being damaged and shall compensate the other party for any damage to the property of such other party.
- 3. Should said common wall be damaged or destroyed by any cause other that the intentional or negligence act of the other party, the same shall be rebuilt or repaired to a condition equal to or better than its condition immediately prior to its being damaged, at the joint expense of both parties, provided that any sums received by insurance against such damage or destruction shall be first applied to such repair or restoration.
- 4. This agreement shall run, with the land and shall be binding upon the parties, their heirs, personal representatives, successors and assigns.
