## SECOND SUPPLEMENT TO DECLARATION OF PLANNED UNIT DEVELOPMENT AND DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR SUMMERLANE AT THE DISTRICT

THIS SECOND SUPPLEMENT TO DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR SUMMERLANE AT THE DISTRICT (AN EXPANDABLE UTAH PLANNED UNIT DEVELOPMENT) (the "Second Supplement") is made and executed by SUMMERLANE DEVELOPMENT, INC., a Utah Corporation, whose principal address is 273 N. ## RECITALS

- A. The original Declaration of Covenants, Conditions, and Restrictions for Summerlane at The District was recorded in the office of the County Recorder of Salt Lake County, Utah on January 24, 2008 as Entry No. 10329358 in Book 9561 at Pages 6442-6500 of the Official Records of the County Recorder of Salt Lake County, Utah (the "Declaration).
- B. The First Supplement to the Declaration of Covenants, Conditions, and Restrictions for Summerlane at The District was recorded in the office of the County Recorder of Salt Lake County, Utah on October 14, 2010 as Entry No. 11052756 in Book 9868 at Pages 5317-5320 of the Official Records of the County Recorder of Salt Lake County, Utah (the "First Supplement").
- C. The Amended and Restated Declaration of Covenants, Conditions, and Restrictions and Reservations of Easements and Bylaws for Summerlane at The District was recorded in the office of the County Recorder of Salt Lake County, Utah on August 17, 2011 as Entry No. 11229196 in Book 9943 at Pages 7399-7457 of the Official Records of the County Recorder of Salt Lake County, Utah (the "Declaration).

- D. The related Plat Maps for Summerlane at The District have also been recorded in the office of the County Recorder of Salt Lake County, Utah.
- C. Under Article III, Section 49 of the Declaration, Declarant reserved the unilateral right to expand the Project.
- D. Declarant intends to expand the Project and that the real property located in Salt Lake County, Utah and described with particularity on Exhibits "A" (Summerlane at The District Phase 7) attached hereto and incorporated herein by this reference (the "Property") be submitted to the Utah Community Association Act, Utah Code Ann., Sections 57-8a-1 et seq. (2004) as amended (the "Act") and subject to the Declaration.
  - E. Declarant is the owner of the Property.

## AGREEMENT

NOW, THEREFORE, for the reasons recited above, and for the benefit of the Project and the Owners thereof, Declarant hereby executes this Second Supplement to the Declaration.

- 1. Supplement to Definitions. Article I of the Declaration, entitled "Definitions," is hereby modified to include the definition of the "Second Supplement to the Declaration" which shall mean and refer to this Second Supplement to the Declaration of Covenants, Conditions, and Restrictions for Summerlane at The District recorded in the office of the County Recorder of Salt Lake County, Utah on January 24, 2008 as Entry No. 10329358 in Book 9561 at Pages 6442-6500 of the Official Records of the County Recorder of Salt Lake County, Utah. Except as otherwise herein provided, the definition of terms contained in the Declaration are incorporated herein by this reference.
- 2. Legal Description. The Property (Summerlane at The District Phase 7) described in Exhibit "A" is hereby submitted to the provisions of the Act and said land shall be held, transferred, sold, conveyed and occupied subject to the provisions of the Declaration, as amended and supplemented.
- 3. Annexation. Declarant hereby declares that the Property (Summerlane at The District Phase 7) is hereby annexed to and subject to the Declaration, which upon recordation of this Second Supplement to the Declaration shall constitute and effectuate the expansion of the Project, making the real property described in Exhibits "A" subject to the functions, powers, rights, duties and jurisdiction of the Association.
- 4. **Effective Date**. The effective date of this Second Supplement shall be the date on which said instrument is filed for record in the Office of the County Recorder of Salt Lake County, Utah.
