MEMORANDUM OF LEASE

THIS MEMORANDUM OF LEASE, dated this 1st day of May, 1997 is between **Terratron Midwest, Inc.**, a Wisconsin corporation and **Titus Foods, Inc.**, a Utah corporation, (collectively, the "LANDLORD"), whose address is 7050 South 2000 East, Suite 300, Salt Lake City, Utah 84121 and **McDonald's Corporation**, a Delaware corporation (the "TENANT"), whose principal place of business is located at One McDonald's Plaza, Oak Brook, Illinois 60521.
