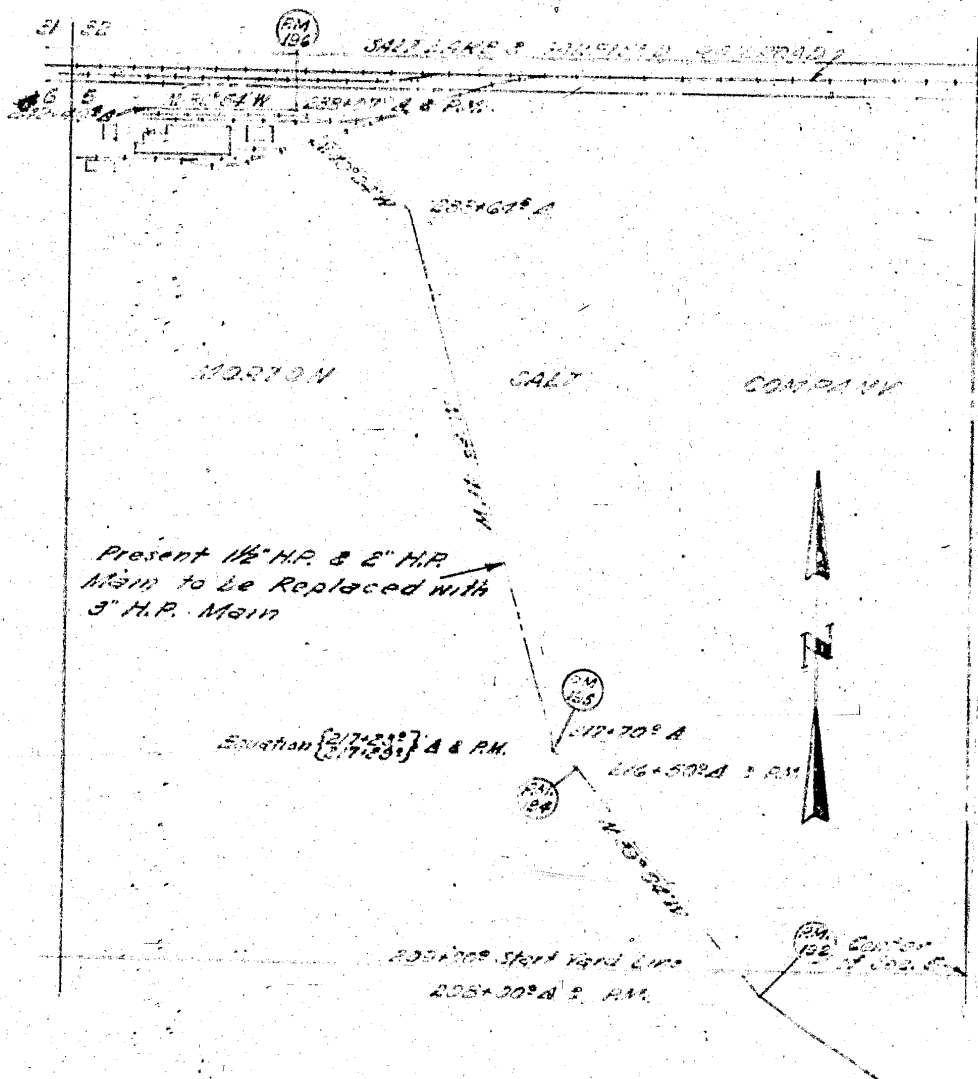

RIGHT OF WAY GRANT

Morton Salt Company, a Corporation of the State of Illinois Grantor, does hereby convey and warrant to MOUNTAIN FUEL SUPPLY COMPANY, a corporation of the State of Utah, Grantee, its successors and assigns, for the sum of

One Dollars, (\$ 1.00 ) receipt of which is hereby acknowledged, a right of way and easement to lay, maintain, operate, repair, remove and replace pipe lines, gates and gate-boxes for the transportation of gas through and across the following described land and premises in Salt Lake County, State of Utah, to-wit:

The N.W. 1/4 of Sec., 5, T. 1 S., R. 2 W., S.L.B & M.

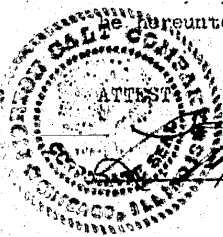
The center line of which said gas pipe line shall extend through and across the above-described land and premises on a line described as follows, to-wit:

Center line of gas main to be located approximately as shown on attached print.

TO HAVE AND TO HOLD the same unto the said Mountain Fuel Supply Company, its successors and assigns, so long as such pipe line or lines, gates or gate-boxes shall be maintained, with the right of ingress and egress to and from said right of way to maintain, operate, repair, remove and replace the same. The said Grantor to fully use the said premises, except for the purposes for which this right of way and easement is granted to the said Grantee.

The said Grantor, for the consideration referred to above, does hereby release and discharge the said Grantee, Mountain Fuel Supply Company, of and from any and all damages, claims, demands, actions or suits on account of damages to the above-described land and premises sustained by the said Grantor, its successors and assigns, because of the construction, maintenance or operation of said pipe line.
