AN ORDINANCE

AN ORDINANCE VACATING PORTION OF 24th East Street, south 132 ft. from Lynwood Drive (National Avenue) and alleys in Blk. 2, Fairmont Subdivision, a platted subdivision located in the Southwest Quarter of the Northeast Quarter of Section 22, Township 1 South, Range 1 East, Salt Lake Base and Meridian.

Be it ordained by the Board of Commissioners of Salt Lake City, Utah:

SECTION 1. That a portion of 24th East Street, south 132 feet from Lynwood Drive (National Avenue) and alleys in Blk. 2, Fairmont Subdivision, a platted subdivision located in the Southwest Quarter of the Northeast Quarter of Section 22, Township 1 South, Range 1 East, Salt Lake Base and Meridian, and being more particularly described as follows:

Portion of 24th East Street south 132 ft. from Lynwood Drive (National Avenue).

Beginning at the northwest corner of Lot 1, Blk. 2, Fairmont Sub. of the S.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ of Section 22, T. 1 S. R. 1 E., S.S.B. & C. 132 ft. south 132 ft. thence east 66 ft., thence north 132 ft., thence east 66 ft. to the place of beginning.

Alleys in Blk. 2, Fairmont Subdivision.

Beginning at the northeast corner of Lot 1, Blk. 2, Fairmont Sub. of the S.W. $\frac{1}{4}$ of the N.E. $\frac{1}{4}$ of Section 22, T. 1 S. R. 1 E., S.S.B. & C. 132 ft. south 264 ft., thence east 12 ft., thence north 120 ft., thence N. 39 deg. 48 min. E. 72 ft., thence east 12 ft., thence S. 39 deg. 48 min. E. 7.81 ft., thence south 120 ft., thence east 12 ft., thence north 264 ft., thence west 12 ft., thence S. 39 deg. 48 min. W. 7.81 ft., thence west 264 ft., thence north 120 ft., thence west 12 ft., to the place of beginning. The boundaries to be and the same are hereby vacated and declared no longer to be public property for use as streets, avenues, alleys or other similar ways.

Said vacated property is expressly subject to all existing rights of way and easements of all public utilities of any kind and every right of way not located in or under or over the confines of the above described property and also subject to the right of the City to enter thereon for inspecting, maintaining, repairing, replacing, removing, altering or re-routing said utilities and all of them.

SECTION 2. In the opinion of the Board of Commissioners it is necessary to the peace, health and safety of the inhabitants of Salt Lake City that this ordinance shall become effective immediately.

SECTION 3. This ordinance shall take effect upon its first publication. Passed and adopted by the Board of Commissioners of Salt Lake City, Utah, this 4th day of May, A.D. 1949.
