E A S E M E N T

WITNESSETH: For and in consideration of the sum of One Hundred Two (\$102.00) Dollars, and other good and valuable consideration, cash in hand paid, receipt of which is hereby acknowledged. The party of the first part, bargained, sold, and by these presents, do bargain, sell, convey, and transfer, and deliver unto Payson City, a Municipal Corporation, a permanent easement and right-of-way, including a perpetual right to enter upon the real estate, hereinafter described for the purpose of constructing and maintaining a sewer line, over and through the lands hereinafter described. The land affected by the grant of this easement and right-of-way, is located in the County of Utah, State of Utah, and more particularly described as follows:

Sewer Easement Centerline Description.

Beginning at a point on the Southeasterly edge of South Ridge Lane, a street in Payson City, Utah 18.5 feet Southwesterly from the North property corner of the J. Clark Elmer property also being the corner formed by the intersection of the Northeasterly right-of-way line and the Southeasterly right-of-way line and the Southeasterly right-of-way line of South Ridge Lane; thence running S 35°15' E 74.5 feet; thence N 66°05' E 190 feet parallel with the North property to a point which is 15 feet from the N.E. property line; thence N 33°30' E 15 feet to the N.W. property line.

Sewer Easement shall include 15.0 feet on each side of above centerline description.

The party of the second part agrees to repair all damages done to the property, and place it back in the same condition as when the second party entered. The party of the second part shall have the right to come upon the land and repair and maintain said sewer line.

To have and to hold said easement and right-of-way, unto the Payson City, a Municipal Corporation, its successors and assigns forever.
