RIGHT-OF-WAY GRANT

FOR AND IN CONSIDERATION OF TEN Dollars, in hand paid, the receipt whereof is hereby acknowledged, MODESTA BERTAGNOLE, of Salt Lake City, Utah.

do hereby for her and her heirs, executors, administrators, successors and assigns grant and release to MOUNTAIN FUEL SUPPLY COMPANY, a corporation organized and existing under and by virtue of the laws of the State of Utah, its successors and assigns, the right-of-way to lay, maintain, operate, inspect, repair and remove pipe lines, and to erect, maintain, operate, inspect, repair and remove telegraph and telephone lines, together with such stations, meter houses, and other facilities and structures as may be necessary or convenient for the operation, maintenance, inspection, protection and repair of said lines over and through lands in Township 1 North, Range 2 East, S.L.B. 34, County of Salt Lake, State of Utah.

including the waiver and release of the right of homestead, with the right of ingress and egress to and from the same. The aforesaid MODESTA BERTAGNOLE to fully use and enjoy the said premises except for the purposes heretofore granted to the said MOUNTAIN FUEL SUPPLY COMPANY, which hereby agrees to pay any damages which may arise to the crops or fences from the laying, erecting, maintaining, operating, inspecting, repairing or removing of said pipe, telegraph and telephone lines, and other facilities and structures. Said damages, if not mutually agreed upon, to be ascertained and determined by three disinterested persons, one of whom to be appointed by the said MOUNTAIN FUEL SUPPLY COMPANY, its successors or assigns, one by the said MODESTA BERTAGNOLE, her

It is expressly understood between the parties hereto, in the execution of this instrument, that all damages arising in connection with the construction of a 20" pipe line during 1949 are satisfied. It is further agreed that no soil shall be removed, nor any structure or structures be erected or permitted, closer than five (5) feet to either side of any pipe line constructed under this grant.

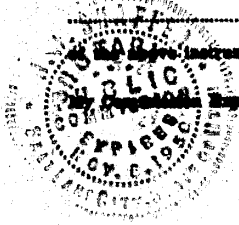
