**NOW, THEREFORE, IT IS RESOLVED** that the following policy is hereby adopted by the Association:

1. <u>Transfer Fees</u>. A transfer fee shall not be charged or due upon the sale or conveyance of a Unit. No seller, buyer, title company, or other person or entity shall henceforth be liable or responsible for payment of any transfer fee to the Association as a result of a sale or conveyance of a Unit.
