## **DECLARATION OF RESTRICTIVE COVENANT**

This Declaration of Restrictive Covenant ("Declaration"), made this 21 day of July, 2014, by Magna Investment and Development, LTD., a Utah Limited Partnership ("Owner"), in favor of WDG Sandy, LLC, a Utah Limited Liability Company ("Buyer").

WHEREAS, Owner holds fee-simple title to Lots 4 and 5 of Little Cottonwood Center Subdivision, as recorded in the Salt Lake County recorder's office;

WHEREAS, Owner has contracted to sell Lot 4 to Buyer in a Real Property Purchase Agreement dated March 20, 2014 ("Purchase Agreement");

WHEREAS, the Purchase Agreement provides that Owner shall prohibit the use of Lot 5, as legally described in Exhibit "A", attached hereto and made a part hereof, ("Property") to be used by an individual or business entity whose primary business is the sale of chicken; and

WHEREAS, the Owner is desirous of making a binding commitment to assure that Lot 5 shall be used in accordance with the representations and commitments found in the Purchase Agreement;

NOW THEREFORE, the Owner voluntarily covenants and agrees that the Property shall be subject to the following restriction that is intended and shall be deemed to be a covenant running with the land and binding upon the Owner of the Property, its successor in interest and assigns as follows:

- 1. The recitals and finding set forth in the preamble of this Declaration are hereby adopted by reference thereto and incorporated herein as if fully set forth in this Section.
- 2. No person or entity shall operate a restaurant or other food establishment on the Property whose primary business or product is the sale of chicken, including without limitation, chicken sandwiches and chicken on the bone.
- 3. This voluntary Declaration shall remain in full force and effect and shall be binding upon the Owner of the Property, its successors in interest and assigns for a period of Fifty (50) years from the date this instrument is recorded in the public records or at such a time as a restaurant whose primary business or product is the sale of chicken is no longer operating on Lot 4, whichever event occurs first.
- 4. This declaration shall be recorded in the Public Records of Salt Lake County, Utah, at the cost of the Owner.
