With the recording of the Silver Creek Village Center Lot 13 & Lot 16 Subdivision plat (Entry #1147487 recorded on 11/13/2020), there was some confusion about which street each lot should use for its situs address. Now that homes are being constructed, the front doors are facing a different street than the street on which they have addresses. This memorandum will correct the addresses of the lots with their front doors facing a different street than the original assigned address.
