AN ORDINANCE
VACATING
A PORTION OF DUDER STREET (LAWRENCE STREET)
IN SALT LAKE CITY, UTAH.
 BEFORE ME, the Mayor of Salt Lake City, Utah, the Board of Commissioners of Salt Lake City, Utah:

SECTION 1. That a portion of Duder Street, located in Salt Lake City, Utah, more particularly described as follows:

Tract No. 1—Beginning at the corner of Duder Street and Charles S. Dwyer's 2nd Addition, running thence east 18 feet, thence south 148 feet, thence west 18 feet, thence north 148 feet to the place of beginning.

Tract No. 2—Beginning at the corner of Duder Street and Charles S. Dwyer's 2nd Addition, running thence east 18 feet, thence south 148 feet, thence west 18 feet to the southeast corner of the aforesaid Lot 2, thence north 148 feet to the place of beginning.

Tract No. 3—Beginning at the corner of Duder Street and Charles S. Dwyer's 2nd Addition, running thence east 18 feet, thence south 148 feet, thence west 18 feet to the southeast corner of the aforesaid Lot 3, thence north 148 feet to the place of beginning.

and declared no longer to be public alley or pedestrian way.

Said vacation is made expressly subject to all existing right of way easements and all other interests of any and every description located on, in, under or over the confines of the above described property, and subject to the right of entry thereon for the purpose of specifying, maintaining, repairing, replacing, removing, altering or re-securing buildings and all of them.

It is the duty of the Board of Commissioners, it is necessary to the peace, health and safety of the inhabitants of Salt Lake City, Utah, that this ordinance shall become effective immediately.

SECTION 3. This ordinance shall take effect upon its first publication.
