- D. WHEREAS, the presently existing Committee has determined that the certain of the provisions in the Fine Resolution may conflict with the Community Association Act, Utah Code § 57-8a-208 and that the recording of the Fine Resolution was not necessary and unnecessarily clouds title to homes in the community.
- E. WHEREAS, for the reasons stated above, the Management Committee has determined it necessary and desirable that the Fine Resolution be repealed in its entirety, that this resolution be recorded evidencing that resolution, and that any future fine provisions and rules for the community will be adopted in rules that will not be recorded, consistent with the provisions of the Community Association Act, Utah Code § 57-8a-208;

IT IS HEREBY RESOLVED THAT:

- A. The Fine Resolution is hereby repealed in its entirety;
- B. This Resolution shall be recorded to evidence the repeal of the Fine Resolution and that it shall have no effect whatsoever going forward (to the extent it had any legal effect at all) on title to any home in the community; and
- C. Any rules adopted by the community in the future and any fine provisions therein will not be recorded.
