## NOTICE OF REINVESTMENT FEE COVENANT

(Highland Vista)

Pursuant to Utah Code Ann. § 57-1-46(6), the Highland Fields Homeowners Association ("Association") hereby provides this Notice of Reinvestment Fee Covenant which burdens all of the real property described in Exhibit A (the "Burdened Property"), attached hereto, which is subject to the Declaration of Covenants, Conditions, and Restrictions for Highland Fields recorded with the Utah County Recorder on December 18, 2018 as Entry No. 119268:2018, and any amendments or supplements thereto (the "Declaration").
