THREE FOUNTAINS NORTH OGDEN CONDOMINIUM PROJECT

This Amendment to the By-Laws is made on the 2/ day of 2000 , 1992, by Three Fountains North Ogden Condominium Homeowners Association Body, pursuant to two-thirds vote of those in attendance at a duly called and constituted general annual meeting of the Unit Owners and pursuant to the provision of paragraph 17 of the Declaration of Condominium.

It is hereby proposed that Paragraph V, sub-paragraph 1, called Designation and Election, Book 1030, Page 274 of the By-Laws be amended to read as follows:

I. Designation and Election. The principal officers of the Management Committee will be a Chairman, a Vice-Chairman, a Secretary, a Treasurer, and a Board Member, all of whom will be elected for specific positions on the committee. Three (3) committee members will be elected to serve a two (2) year term of office. The offices will be a Chairman, a Treasurer, and a Board Nember. The following year two (2) members will be elected. They will be the offices of a Vice-Chairman and a Secretary. This procedure will allow an overlapping program of office tenure. At each annual Homeowners meeting the outgoing members will be replaced by election to serve for two (2) years.

- 2. <u>Vacancies</u>. Vacancies which occur in the Management Committee between annual regular elections will be filled by appointments made by the remaining committee members. Appointees will serve out the term of the member whose place they are being appointed to fill.
- members to serve on the Management Committee will be made from the floor. The person being nominated must indicate a willingness to serve. The ballot will reflect the specific office for which the candidate is nominated.
- 4. <u>Candidate Requirements</u>. All candidates for positions on the Management Committee must meet the following requirements:
 - (a) The candidate must be a homeowner.
 - (b) The candidate must be a resident of the complex.
 - (c) The candidate must be current on all fees and assessments.
 - 5. Other Officers.
 - 6. Chairman,
 - 7. Vice-Chairman.
 - 8. Secretary.
 - 9. Treasurer.
 - 10. <u>Board Member</u>. The Board Member will assist in the conduct of the affairs of the Condominium Project.
 - 11. Compensation.
