
BE IT KNOWN TO ALL SELLERS, BUYERS AND TITLE COMPANIES that:



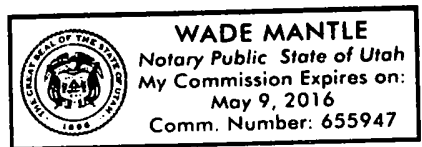
