At a public meeting held on Friday, 3 April 2015, the Department of Community Development approved a conditional use permit to install an electric message center sign in the face of the existing sign at Master Muffler located at 3865 South State Street, with the following conditions:

- 1. Light intensity may not exceed that produced by fifty-four (54) watts of incandescent lighting for daytime usage, as measured from the nearest public right-of-way. An automatic dimmer must be installed to reduce nighttime intensity to that produced by thirty (30) watts of incandescent lighting, as measured from the nearest public right-of-way.
- 2. The digital face may not flash or scintillate except to change the displayed wording to different wording.
- 3. Any display on the digital face must remain lighted for at least two seconds.
- 4. The applicant shall obtain a South Salt Lake City sign permit for the electronic message center.
- 5. All items of the staff report.
