AMENDMENT TO DECLARATION OF CONDOMINIUM AND BYLAWS OF COVENTRY MANOR CONDOMINIUM

This Amendment to Declaration of Condominium and Bylaws of Coventry Manor Condominium is made and executed by Coventry Manor Homeowners Association, of 487 East Edindrew Circle, Murray, UT 84107 (the "Association").

RECITALS

- A. The Declaration of Condominium of Coventry Manor Condominium (the "Declaration") and Bylaws ("Bylaws") were recorded in the office of the County Recorder of Salt Lake County, Utah on December 13, 1979 as Entry No. 3377254 in Book 5005 at Page(s) 655-689 of the official records.
- B. The Association is the managing agent of the real property located in Salt Lake County, Utah, described with particularity on Exhibit "A," attached hereto and incorporated herein by this reference (the "Property").
 - C. The Property is subject to the Declaration and Bylaws.
- D. The Association is comprised of all of the Unit Owners at Coventry Manor Condominium taken or acting as a group in accordance with the Declaration and Bylaws.
 - E. The Bylaws are the administrative rules directing the affairs of the Association.
- F. All of the voting requirements to amend the Declaration and Bylaws have been satisfied.

NOW, THEREFORE, for the reasons recited above, and for the benefit of the Property and the owner thereof, the Association hereby executes this Amendment to Bylaws of Coventry Manor Condominium.

1. Article 20, Section (b) of the Declaration and Article 2 of the Bylaws are hereby amended to change the number of members of the Management Committee¹ from seven (7) to five (5).

¹ also known as the Board of Directors.

- 2. In the event of any conflict, incongruity or inconsistency between the provisions of the Bylaws and this Amendment, the latter shall in all respects govern and control.
- 3. The effective date of this Amendment is the date it is recorded in the office of the County Recorder of Salt Lake County, Utah.
