The grantor reserves rights to use the abutting state property for highway purposes and excludes from this grant any rights to air, light, view and visibility over and across the abutting state property. The Grantee is hereby advised that due to present or future construction on the adjacent highway including but not limited to excavation, embankment, structures, poles, signs, walls, fences and all other activities related to highway construction or which may be permitted within the Highway Right of Way that air, light, view and visibility may be restricted or obstructed on the above described property.

Together with and subject to any and all easements, rights of way and restrictions appearing of record or enforceable in law and equity.

Junkyards, as defined in 23 United States Code, Section 136, shall not be established or maintained on the above described tracts of lands.

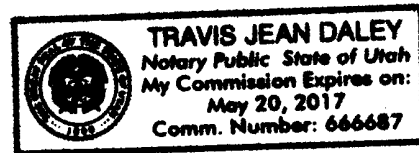


Exhibit "A"

A tract of land situate in the NW¼SE¼ of Section 1, T3S, R1W, SLB&M. The boundaries of said tract of land are described as follows:

Beginning in the north boundary line of an entire tract of property at a point 1415.39 ft (431.411 meters) S 89°59'37" W along the Quarter Section line and 619.28 ft (188.757 meters) SOUTH from the East Quarter corner of said Section 1, said point being 35.93 ft (10.950 meters) perpendicular distant northwesterly from the centerline of a connector road known as Monroe Street incident to the reconstruction of a freeway known as Project No. 15-7 at Engineer Station 15+418.626 meters; and running thence Southwesterly 196.87 ft (60.006 meters) along the arc of an 259.35 ft (79.050 meter) radius curve to the right concentric with said centerline (Note: Chord bears S 55°48'36" W 192.17 ft or 58.573 meters) to the west boundary line of said entire tract; thence NORTH 107.99 ft (32.915 meters) along said west boundary line to the Northwest corner of said entire tract; thence EAST 158.96 ft (48.451 meters) along said North boundary line of said entire tract to the point of beginning as shown on the official map of said project on file in the office of the Utah Department of Transportation. The above described tract of land contains 10,965 sq ft or 0.252 acre, more or less.
