AMENDMENT TO THE BYLAWS of TALONS COVE TOWNHOMES HOA

This Amendment to Bylaws of Talons Cove Townhomes HOA (this "Amendment"), that, in connection with a recorded Declaration governs the development known as Talons Cove is made on the date evidenced below by the Talons Cove Townhomes HOA (hereinafter "Association").

RECITALS

- A. Certain real property in Utah County, Utah, known as Talons Cove subdivision was subjected to certain covenants, conditions, and restrictions pursuant to a Declaration of Covenants, Conditions, and Restrictions for Talons Cove Subdivision ("Declaration"), which included Association Bylaws recorded on May 6, 2014, as Entry Number 30221:2014 in the Recorder's Office for Utah County, State of Utah.
- B. This amendment shall be binding against the property described in the Declaration and Bylaws and any annexation or supplement thereto, as described in **Exhibit A**.
- C. This Amendment to the Bylaws is intended to clarify and define the composition of the Board of Directors for the Association which shall expand the number of Directors and limit the terms held by Directors.
- D. Pursuant to Article 7, Section 7.1 of the Bylaws, the undersigned officer(s) hereby certifies that the voting requirements to amend the Bylaws have been satisfied to adopt this Amendment.

NOW THEREFORE, Article 3, Section 3.1 of the Bylaws is hereby deleted and replaced in its entirety as follows:

3.1 Number and Qualification of Directors

The affairs of the Association shall be governed by a Board composed of five (5) Directors. Directors shall be Members in good standing.

NOW THEREFORE, Article 3, Section 3.2 of the Bylaws is hereby deleted and replaced in its entirety as follows:

3.2 Selection and Term of Directors

Directors shall serve a term of three (3) years and shall serve until their successors have been elected. There is no limit on the number of terms an Owner may serve as a Director. Directors terms shall be staggered as follows: (i) three Directors shall be elected in years ending with an even number; and (ii) two Directors shall be elected in years ending with an odd number.


