E A S E M E N T

WHEREAS, SALT LAKE CITY, hereinafter referred to as "City", owns, operates and maintains an open drainage ditch extending northerly across land owned by UTAH POWER & LIGHT COMPANY, hereinafter referred to as "Company"; and

WHEREAS, the City desires a right of way for the maintenance and operation of said ditch across the land of the Company and the Company is willing to grant the same upon the conditions expressed herein.

NOW THEREFORE, Company does hereby grant to the City a right of way across and under the surface of the land of the Company for the operation, maintenance and repair of a water drainage ditch where the same is presently located, the center line of which is described as follows:

Beginning at a point 286.4 feet west and south 0° 00' 51" west 33.00 feet from the southeast corner of Section 34, T. 1 N., R. 1 W., S.L.B. & M., at the south property line of the Salt Lake, Garfield & Western Railroad; thence south 0° 00' 51" west 285.00 feet to center of south headwall of bridge at intersection of vacated Jordan Avenue and vacated 13th West Street; thence south 0° 00' 51" west 278.00 feet to center of proposed manhole; thence south 17° 22' 06" west 132.05 feet to center of proposed headwall; thence south 24° 51' 36" west 188.8 feet to center of north headwall of culvert under Union Pacific and Western Pacific Railroad tracks.

Ten feet wide where enclosed and twenty feet wide where open.

Or at any other location thereon selected by and located at the expense of the Company in accordance with this agreement so long as the same is used by the City for the drainage of water and no longer, subject to the following conditions:

Company reserves the right to:

1. Enclose the said drainage ditch across its land in a pipe 42 inches inside diameter, the plans and specifications of which shall be approved by the City prior to construction.
2. Change the course of said drainage ditch across its said land provided the plans for such change, including the gradient and facilities to permit the City to clean and maintain the same, are approved by the City Engineer.
3. Use the right of way for any purpose which does not interfere with the flow of water in the pipe or ditch.
