construct, repair, remove, replace, reconstruct, patrol, inspect, improve, enlarge and maintain electric transmission and distribution lines and communication facilities, both overhead and underground, including towers, poles and other supports, together with braces, guys, anchors, cross-arms, cables, conduits, wires, conductors, manholes, transformers and other fixtures, devices and appurtenances used or useful in connection therewith, and full right and authority to cut, remove, trim or otherwise control all trees, brush and other growth on or overhanging said premises.

At no time shall any flammable material or any building of any kind be placed or erected within the boundaries of said right-of-way, nor shall any equipment or material of any kind that exceeds 16 feet in height be placed or used thereon by Grantor or by Grantor's heirs, successors or assigns.

Lessee shall pay for damages caused by Lessee's installation, use, maintenance, repair, alteration, replacement or removal of the wood pole or steel tower lines, together with the cross-arms and other attachments to houses, barns, growing crops and fences. If such damages occur, Lessor shall present to Lessee the bill for such damages which shall be paid within a reasonable time.

Subject to the foregoing limitations, said right-of-way may be leased by Grantor for roads, agricultural crops and other purposes not inconsistent with this easement.
