IN THIS ACTION, Defendant David Young (“**Defendant**”), having been regularly served with process and having failed to appear and answer Plaintiff’s Complaint filed herein, the legal time for answering having expired, and the default of the Defendant having been entered according to law, for good cause appearing and now upon the application of Plaintiff Riverton Motor Company, Inc. dba Riverton Chevrolet (“**Plaintiff**” or “**Riverton Chevrolet**”), judgment is hereby entered against Defendant and in favor of Plaintiff in accordance with the prayer of the Complaint.

WHEREFORE, by virtue of the law, and by reason of the premises aforesaid, it is ordered, adjudged and decreed that Plaintiff recover from the Defendant the sum of \$82,060.07, plus pre and post-judgment interest thereon from June 7, 2016 until paid in full, together with attorneys’ fees incurred herein, court costs, and all other costs of collection in the amount of \$7,923.50, consisting of \$7,160.50 in attorneys’ fees, and \$763.00 in costs.

IT IS FURTHER ORDERED THAT Riverton Chevrolet is authorized to immediately sell, transfer, liquidate or otherwise encumber the 2016 Chevrolet Silverado 3500HD, VIN No.

1GC4K0E85GF162983(the “**Vehicle**”), which has already been repossessed pursuant to the Court’s September 21, 2016 Writ of Replevin and Assistance, pursuant to the underlying agreements, the provisions of the Uniform Commercial Code and applicable law;

IT IS FURTHER ORDERED THAT Riverton Motors is entitled to punitive damages pursuant to its Fifth Cause of Action. Without further hearing on this issue, the Court awards \$10,000.00 as punitive damages. Plaintiff may schedule a hearing on the issue of punitive damages if so desired.

IT IS FURTHER ORDERED THAT THIS JUDGMENT SHALL BE AUGMENTED IN THE AMOUNT OF REASONABLE COSTS AND ATTORNEYS’ FEES EXPENDED IN COLLECTING SAID JUDGMENT BY EXECUTION OR OTHERWISE AS SHALL BE ESTABLISHED BY AFFIDAVIT.

IT IS SO ORDERED.
