AN ORDINANCE, AMENDING TITLE 19, ENTITLED "ZONING" OF THE SALT LAKE COUNTY CODE OF ORDINANCES, 2001, BY RECLASSIFYING CERTAIN PROPERTY LOCATED IN SALT LAKE COUNTY FROM THE A-1 Z/C ZONE TO THE R-M ZONE; R-1-6 ZONE; R-1-5 Zone; and R-1-4 ZONE.

The Salt Lake County Council of Salt Lake County, State of Utah, ordains as follows:

Section 1: Section, 19.06.020, The Zoning Map of Salt Lake County, Salt Lake County Code of Ordinances 2001, is hereby amended, as follows:

The properties described in **Application #30095** filed by Dustin Holt, and located at **7445** W UTWO O ONE HWY within Salt Lake County, is hereby reclassified from the A-1 Z/C Zone to the R-M Z/C Zone; R-1-6 Z/C Zone; R-1-5 Z/C Zone; and R-1-4 Z/C Zone; with the following zoning conditions:

- Heights of structures are limited to 3 stories and no more than 35 feet;
- Uses are limited to residential only.
